

Conversion to Water Injection - MCA Unit Well No. 67 - L-21-17-32, Lea County, New Mexico

Permission is hereby requested to convert for water injection MCA Unit Well No. 67 located 1980¹ from the south line and 660¹ from the west line of Section 21, Township 17 South, Range 32 East, Lea County, New Mexico. Order No. R-2403 authorized a pilot waterflood project consisting of four injection wells, Nos. 68, 113, 116, and 235 as injectors with Well No. 234 in the center. The first expansion was authorized by Administrative Order WFX-197 providing for the addition of 13 injection wells. The expansion and all subsequent expansions have been on an 80-acre five spot pattern but were inconsistent with the original pilot pattern. It is proposed to convert Well No. 67 so that the system of alternate injection wells on regular locations will be completed in this area. This action should materially improve the performance of Wells Nos. 66, 262, 47, and 46.

Since there are no offset operators to this well, it is respectfully requested that authority be granted to convert MCA Unit Well No. 67 without a waiting period.


