ADMINISTRATIVE ORDER
OF THE OIL CONSERVATION COMMISSION

Under the provisions of Order No. R-4009, Murphy H. Baxter has made application to the Commission on July 10, 1972, for permission to expand its North EK Queen Unit Water Flood Project in the EK Yates-Seven Rivers-Queen Pool, Lea County, New Mexico.

NOW, on this 25th day of July, 1972, the Secretary-Director finds:

1. That application has been filed in due form.
2. That satisfactory information has been provided that all offset operators have been duly notified of the application.
3. That no objection has been received within the waiting period as prescribed by Rule 701.
4. That the proposed injection wells are eligible for conversion to water injection under the terms of Order No. R-4009.
5. That the proposed expansion of the above-referenced water flood project will not cause waste nor impair correlative rights.
6. That the application should be approved.

IT IS THEREFORE ORDERED:

That the applicant, Murphy H. Baxter, be and the same is hereby authorized to inject water into the Queen formation through the following described wells for purposes of secondary recovery, to wit:

Tract 1 Well No. 3 located in Unit J of Section 36, Township 17 South, Range 33 East, NMPM,
Tract 2 Well No. 1 located in Unit I and Tract 2 Well No. 4 located in Unit B both in Section 1, Township 18 South, Range 33 East, NMPM, Tract 3 Well No. 1 located in Unit D and Tract 3 Well No. 3 located in Unit F both in Section 6, Township 18 South, Range 34 East, NMPM.

PROVIDED HOWEVER, that the applicant shall inject water through tubing with packers set just above the Queen perforations in the above described wells.

DONE at Santa Fe, New Mexico, on the day and year hereinabove designated.
