Proposed Expansion of Maljamar Cooperative Agreement Waterflood -
Pearl B No. 3

Continental Oil Co. wishes to expand the Maljamar Cooperative Agreement Waterflood in the Maljamar (Grayburg - San Andres) Pool by adding as an injection well it's Pearl B Well No. 3 located 680' from the South line 1980' from the West line of Section 30, T-17S, R-33E. As shown on the attached plat the well is located outside the participating area of the MCA unit but is inside the project area of the Maljamar Cooperative Agreement. The well is proposed to complete the pattern of injection wells surrounding MCA Unit Well No. 199 located in Unit K of Section 30.

The attached log shows the interval into which the water will be injected in the subject well. The attached diagramatic sketch shows the manner in which the well will be equipped for injection. The annular space above the packer between tubing and casing will be filled with treated water and equipped at the surface so that water entering into the space will be readily detectable.

By copy of this application the Offset Operators are being notified of this application. It is respectfully requested that administrative authority be given, under the provisions of Order No. R-2403A, to expand the Maljamar Cooperative Agreement Waterflood Project in the Maljamar Pool by the addition of the Pearl B No. 3 as an injection well.

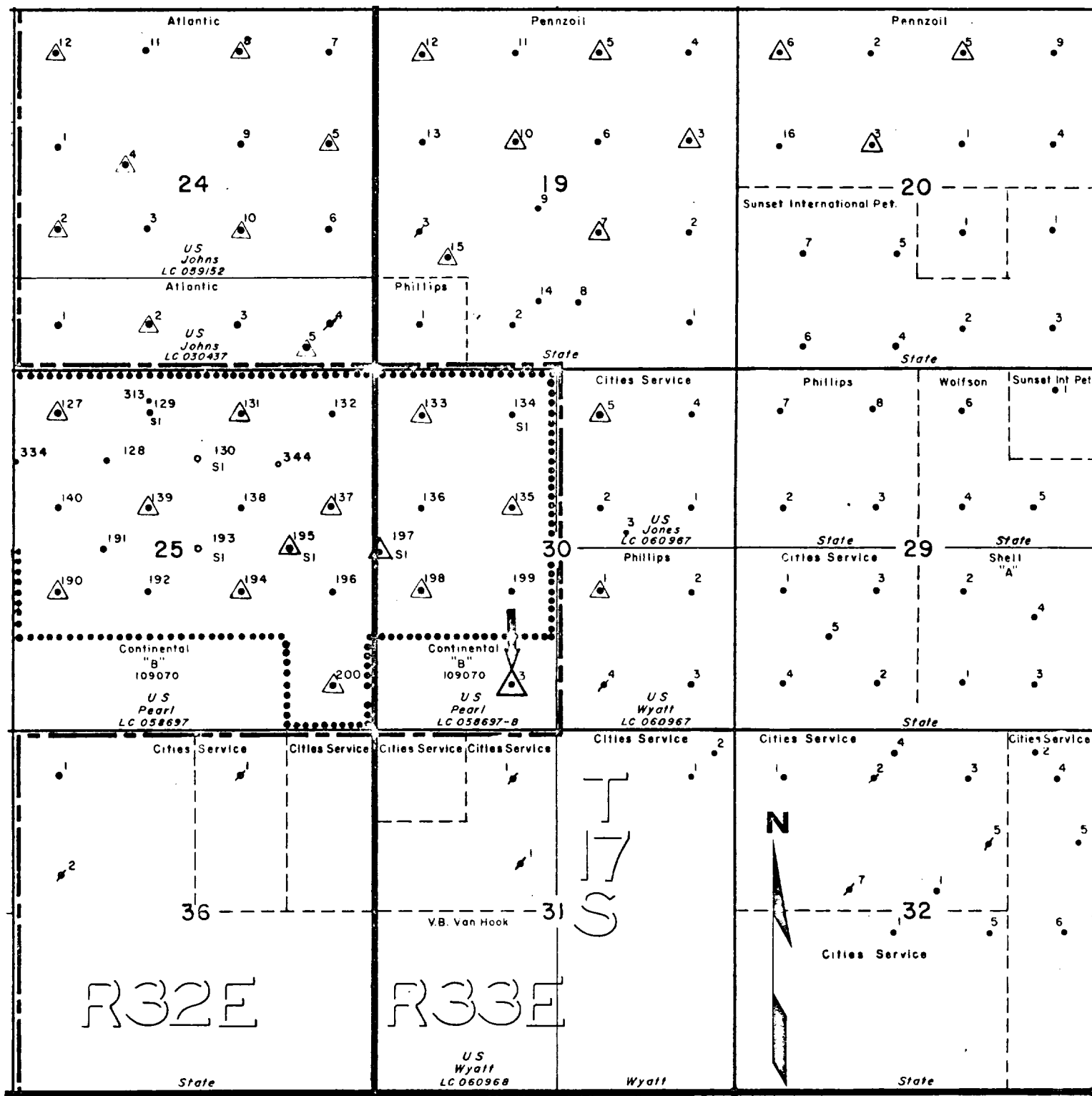

△ INJECTION WELL

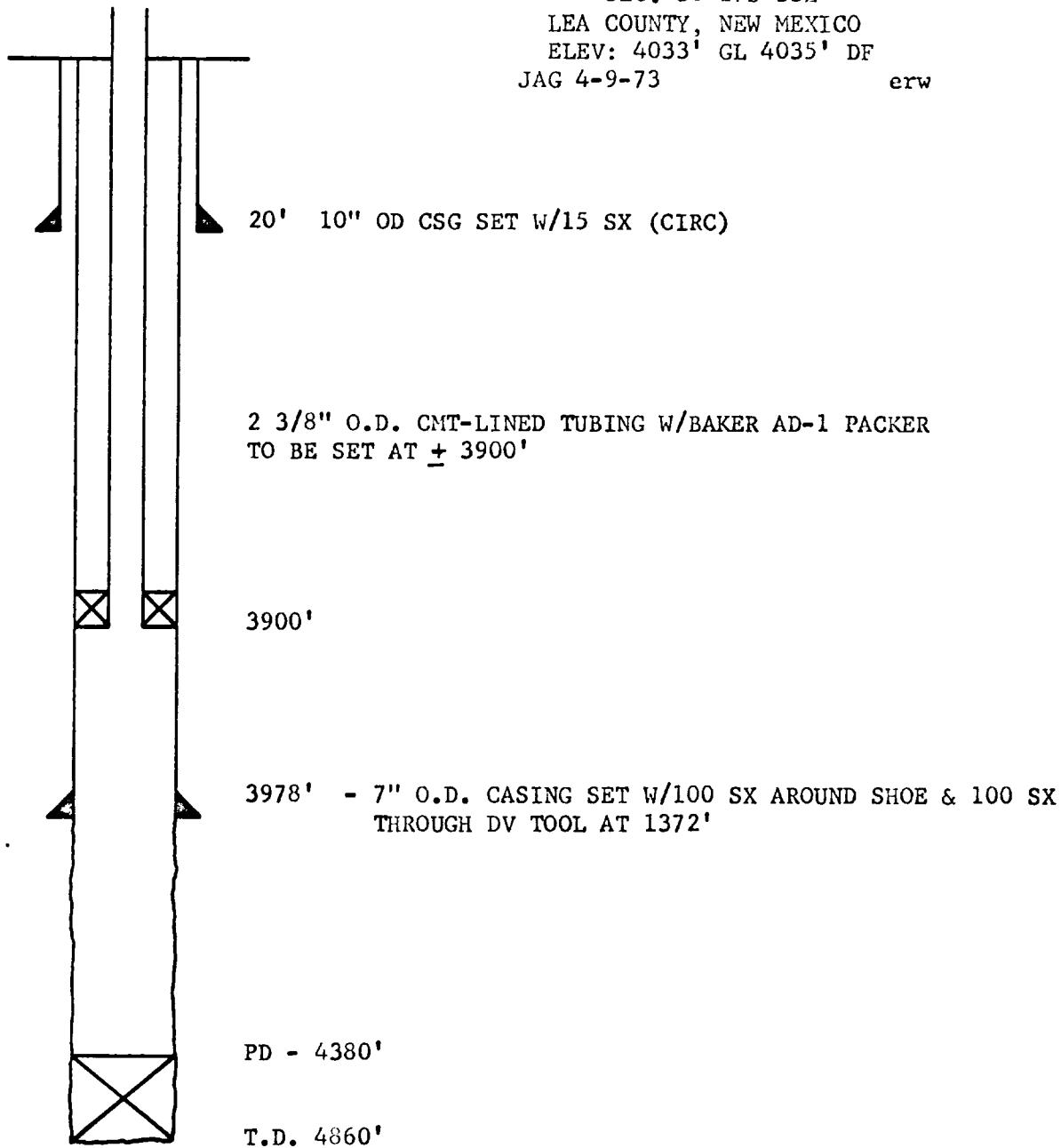
--- PROJECT AREA BOUNDARY

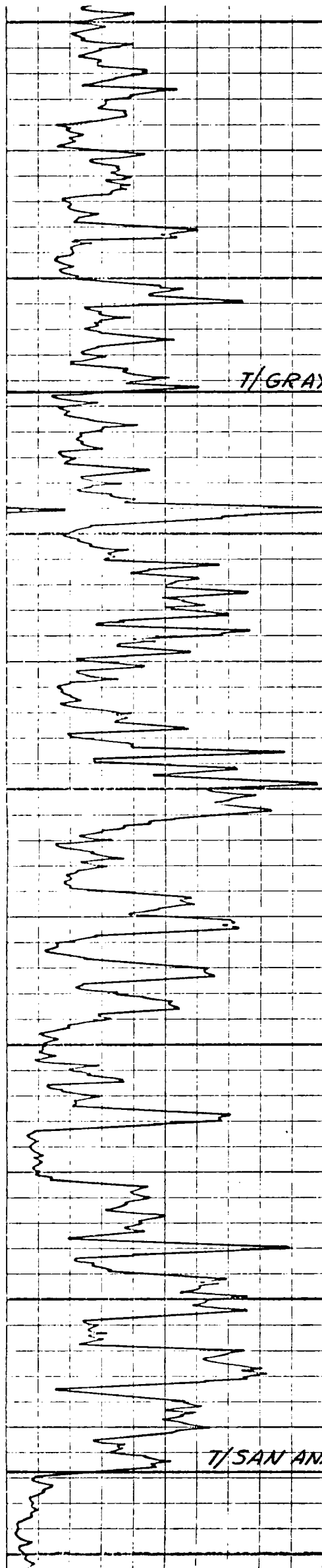

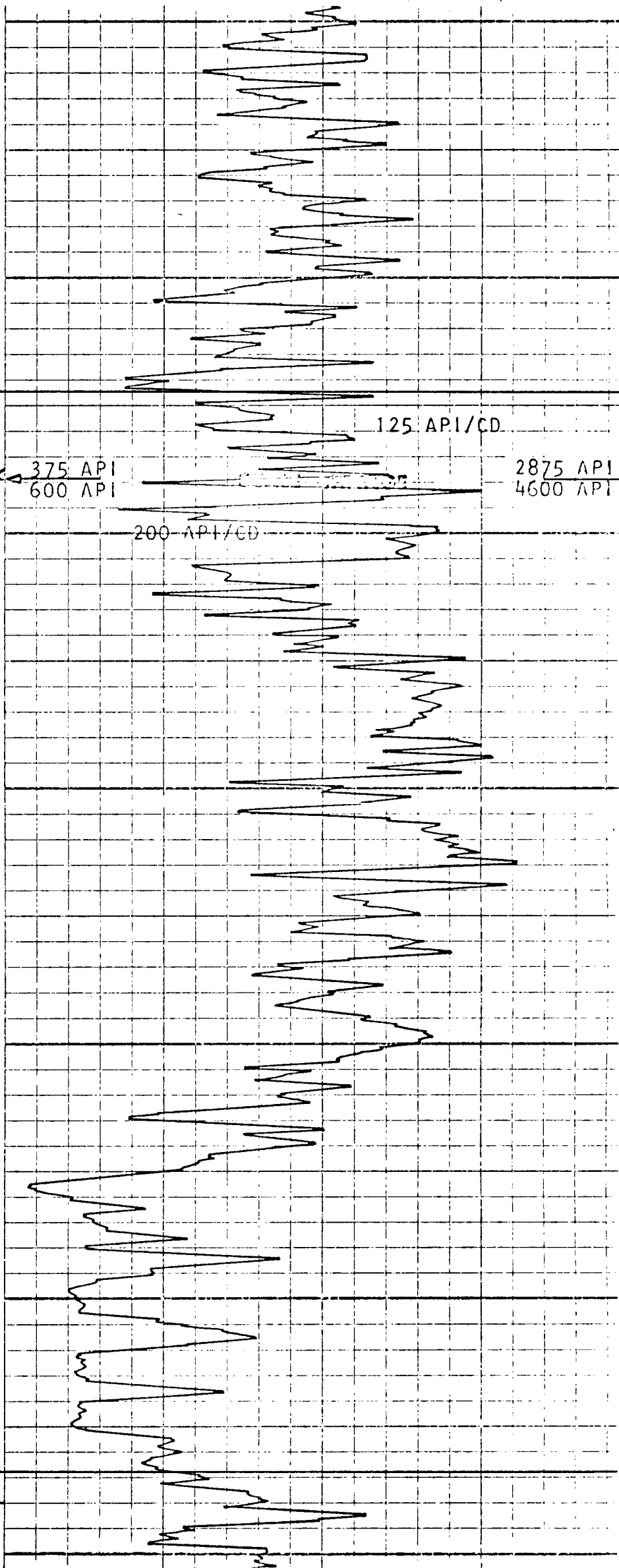
