ADMINISTRATIVE ORDER
OF THE OIL CONSERVATION COMMISSION

Under the provisions of Order No. R-4214 and R-4290, McClellan Oil Corporation has made application to the Commission on March 21, 1974, for permission to expand its Sulimar-Queen Unit Water Flood Project in the Sulimar-Queen Pool, Chaves County, New Mexico.

NOW, on this 22nd day of March, 1974, the Secretary-Director finds:

1. That application has been filed in due form;
2. That satisfactory information has been provided that all offset operators have been duly notified of the application.
3. That waivers of objection have been received from offsetting operators and the waiting period as prescribed by Rule 701-E may be dispensed with;
4. That the proposed injection well is eligible for conversion to water injection under the terms of Order No. R-4214 and R-4290;
5. That the proposed expansion of the above-referenced water flood project will not cause waste nor impair correlative rights; and
6. That the application should be approved.


IT IS THEREFORE ORDERED:

That the applicant, McClellan Oil Corporation, be and the same is hereby authorized to inject water into the Queen formation through the following described well for purposes of secondary recovery, to wit:

East, NMPM,
