### ADMINISTRATIVE ORDER OF THE OIL CONSERVATION COMMISSION

Under the provisions of Order No. R-3001, Mobil Oil Corporation has made application to the Commission on February 7, 1977, for permission to expand its Denton North Wolfcamp Unit Water Flood Project in the Denton-Wolfcamp Pool in Lea County, New Mexico.

NOW, on this 9th day of February, 1977, the Secretary-Director finds:

- 1. That application has been filed in due form.
- 2. That satisfactory information has been provided that there are no other offset operators.
- 3. That the proposed injection well is eligible for conversion to water injection under the terms of Order No. R-3001
- 4. That the proposed expansion of the above-referenced water flood project will not cause waste nor impair correlative rights.
  - 5. That the application should be approved.

#### IT IS THEREFORE ORDERED:

That the applicant, Mobil Oil Corporation, be and the same is hereby authorized to inject water into the Wolfcamp formation through plastic-lined tubing set in a packer at approximately 9058 feet in the following described well for purposes of secondary recovery, to wit:

Denton North Wolfcamp Unit Tract 5 Well No. 10 located in Unit K of Section 35, Township 14 South, Range 37 East, NMPM, Lea County, New Mexico.
