
Dear Mr. Frazier:

Pursuant to the terms of Division Order No. WFX-655 dated February 21, 1994, Texaco was required to re-enter and re-plug the Krupp & Flaherty Moberly Well No. 1 located in Unit J of Section 21, Township 26 South, Range 37 East, NMPM, Lea County, New Mexico, prior to commencing injection operations into its Rhodes Yates Unit Well No. 1, also located in said Section 21. The re-plugging of this well was deemed necessary inasmuch as no plugging report showing the details of plugging could be found.

We have received the plugging report on the aforesaid Moberly Well No. 1 that Texaco obtained from the Bureau of Land Management. Upon review of the plugging report, it has been determined that re-plugging of this well is not necessary.

Texaco is hereby relieved of the requirement contained within Division Order No. WFX-655 to re-enter and re-plug the Krupp and Flaherty Moberly Well No. 1 as described above. All other provisions contained within Division Order No. WFX-655 shall remain in full force and effect.

DETAILS OF WORK

In connection with the abandonment of the above well, the work was completed as follows:

Total Depth 325 1/2 ft.
 A cement plug, 50' in length, extending from below the 7" casing up into the casing.
 A cement plug, 50' in length, extending from above the 7" casing stub down into the stub.
 A cement plug, 50' in length, extending from below the 8 1/4" casing up into the casing.
 A regulation marker cemented in a plug at the surface.
 Intervals between cement plugs were filled with heavy mud.

This work was completed October 29, 1948.

I understand that this plan of work must receive approval in writing by the Geological Survey before operations may be commenced.
