ADMINISTRATIVE ORDER OF THE OIL CONSERVATION COMMISSION

Under the provisions of Order No. R-2541, Humble Oil & Refining Company has made application to the Commission on March 6, 1964, for permission to expand its Many Rocks-Gallup Pressure Maintenance Project in the Many Rocks-Gallup Oil Pool, San Juan County, New Mexico.

NOW, on this 6th day of May, 1964, the Secretary-Director finds:

- 1. That application has been filed in due form.
- 2. That satisfactory information has been provided that all offset operators have been duly notified of the application.
- 3. That no objection has been received within the waiting period as prescribed by Order No. R-2541.
- 4. That the proposed injection wells are eligible for conversion to water injection under the terms of Order No. R-2541.
- 5. That the proposed expansion of the above-referenced water flood project will not cause waste nor impair correlative rights.
 - 6. That the application should be approved.

IT IS THEREFORE ORDERED:

That the applicant, Humble Oil & Refining Company, be and the same is hereby authorized to inject water into the Gallup formation through the following described wells for purposes of Pressure Maintenance, to wit:

Humble Navajo Tribe Well No. G-15 located in the NW/4 NE/4 of Section 2, and Humble Navajo Tribe Well No. G-17 located in the SE/4 NE/4 of Section 12, both in Township 31 North, Range 16 West, NMPM.
