ADMINISTRATIVE ORDER OF THE OIL CONSERVATION COMMISSION

Under the provisions of Order No. R-2211, Pan American Petroleum Corporation has made application to the Commission on November 2, 1964, for permission to expand its Gallegos Canyon Unit Pressure Maintenance Project Area in the Cha Cha-Gallup Oil Pool, San Juan County, New Mexico.

NOW, on this 22nd day of November, 1964, the Secretary-Director finds:

- That application has been filed in due form.
- 2. That satisfactory information has been provided that all offset operators have been notified of the application.
- 3. That no objection has been received within the waiting period as prescribed by Order No. R-2211.
- 4. That the proposed injection well is eligible for conversion to water injection under the terms of Order No. R-2211 and the proposed expansion of the project area is reasonable and necessary to include said well.
- 5. That the proposed expansion of the above-referenced pressure maintenance project will not cause waste nor impair correlative rights.
 - 6. That the application should be approved.

IT IS THEREFORE ORDERED:

That the applicant, Pan American Petroleum Corporation, be and the same is hereby authorized to inject water into the Gallup formation through the following described well for purposes of Pressure Maintenance, to wit:

Gallegos Canyon Unit Well No. 132 located in the SE/4 NE/4 of Section 30, Township 28 North, Range 12 West, NMPM.

PROVIDED HOWEVER, That applicant shall inject water through tubing with a packer set close to the top of perforated interval in the $4-\frac{1}{2}$ inch casing in said well.

IT IS FURTHER ORDERED: That the Pressure Maintenance Project Area described by Order No. R-2211 be expanded to include therein the following area:

Township 28 North, Range 12 West, NMPM

Section 19: SE/4 SW/4 and SW/4 SE/4

Section 29: W/2 NW/4 and NW/4 SW/4

Section 30: E/2 NW/4, NE/4 and N/2 SE/4
