### ADMINISTRATIVE ORDER OF THE OIL CONSERVATION COMMISSION

Under the provisions of Order No. R-1638, The British-American Oil Producing Company has made application to the Commission on May 13, 1965, for permission to expand its West Bisti-Lower Gallup Sand Unit Pressure Maintenance Project in the Bisti-Lower Gallup Oil Pool, San Juan County, New Mexico.

NOW, on this 2nd day of June, 1965, the Secretary-Director finds:

1. That application has been filed in due form.

2. That satisfactory information has been provided that all offset operators have been duly notified of the application.

3. That no objection has been received within the waiting period as prescribed by Order No. R-1638.

4. That the proposed injection well is eligible for conversion to water injection under the terms of Order No. R-1638.

5. That the proposed expansion of the above-referenced pressure maintenance project will not cause waste nor impair correlative rights.

6. That the application should be approved.

IT IS THEREFORE ORDERED:

That the applicant, The British-American Oil Producing Company, be and the same is hereby authorized to inject water into the Lower Gallup formation through the following described well for purposes of pressure maintenance, to wit:

West Bisti Unit Well No. 21 located in the NW/4 NW/4 of Section 34, and West Bisti Unit Well No. 12 located in the SW/4 NW/4 of Section 35, both in Township 26 North, Range 13 West, NMPM.

<u>**PROVIDED HOWEVER**</u>. That applicant shall inject water through tubing with packers set well below the top of the cement surrounding the  $5\frac{1}{2}$ -inch casing in said wells.
