ADMINISTRATIVE ORDER  
OF THE OIL CONSERVATION COMMISSION

Under the provisions of Order No. R-3401, Benson-Montin-Greer Drilling Corporation has made application to the Commission on June 15, 1971, for permission to expand its West Puerto Chiquito-Mancos Pressure Maintenance Project in the West Puerto Chiquito-Mancos Oil Pool, Rio Arriba County, New Mexico.

NOW, on this 5th day of July, 1971, the Secretary-Director finds:

1. That application has been filed in due form.
2. That satisfactory information has been provided that all offset operators have been duly notified of the application.
3. That no objection has been received within the waiting period as prescribed by Order No. R-3401.
4. That two of the proposed injection wells are eligible for conversion to gas injection and a third well is eligible for drilling and completion as a gas injection well under the terms of Order No. R-3401.
5. That the proposed expansion of the above-referenced pressure maintenance project will not cause waste nor impair correlative rights.
6. That the application should be approved.


IT IS THEREFORE ORDERED:

That the applicant, Benson-Montin-Greer Drilling Corporation, be and the same is hereby authorized to inject gas into the Mancos formation through the following described wells for purposes of pressure maintenance, to wit:

Canada Ojitos Unit Well No. 5 located in Unit B of Section 18, Township 25 North, Range 1 East, NMPM,  
Canada Ojitos Unit Well No. 17 located in Unit G of Section 1, Township 24 North, Range 1 West, NMPM,  
and Canada Ojito Unit Well No. 18 located in Unit C of Section 5, Township 25 North, Range 1 East, NMPM,

Done at Santa Fe, New Mexico, on the day and year hereinabove designated.
