ADMINISTRATIVE ORDER
OF THE OIL CONSERVATION COMMISSION

Under the provisions of Order No. R-4430, Mobil Oil Corporation has made application to the Commission on December 5, 1973, for permission to expand its North Vacuum-Abo Unit Pressure Maintenance Project in the North Vacuum-Abo Pool, Lea County, New Mexico.

NOW, on this 17th day of December, 1973, the Secretary-Director finds:

1. That application has been filed in due form.
2. That satisfactory information has been provided that all offset operators have been duly notified of the application.
3. That waivers of objection have been received from offset operators.
4. That the proposed wells are eligible for conversion to gas and/or water injection under the terms of Order No. R-4430.
5. That the proposed expansion of the above-referenced pressure maintenance project will not cause waste nor impair correlative rights.
6. That the application should be approved.

IT IS THEREFORE ORDERED:

That the applicant, Mobil Oil Corporation, be and the same is hereby authorized to inject gas and/or water into the Abo formation through the following described wells for purposes of secondard recovery, to wit:

North Vacuum Abo Unit Well No. 218, located in Unit F,
Section 25, Township 17 South, Range 34 East, NMPM

North Vacuum Abo Unit Well No. 219, located in Unit N,
Section 13, Township 17 South, Range 34 East, NMPM

Gentlemen:

Under the provisions of Order No. 4430, Mobil Oil Corporation respectfully requests approval to drill and complete the subject well for the purpose of injecting gas and/or water into the Abo formation. Well #218 is located 660 ft from the outer boundary line of the North Vacuum Abo Unit, in Unit F, 1880 ft from the north line and 1974.5 ft from the west line of Sec. 25, T-17-S, R-34-E, Lea County, New Mexico.

This well is being drilled to replace Well #108 which will be abandoned in the Abo. Order No. 4430 authorized the use of Well #108 as an injection well.

In support of this application the following items are being submitted in triplicate:


1. Map of the North Vacuum Abo Unit showing the location of the subject well and surrounding wells completed in the Abo formation.

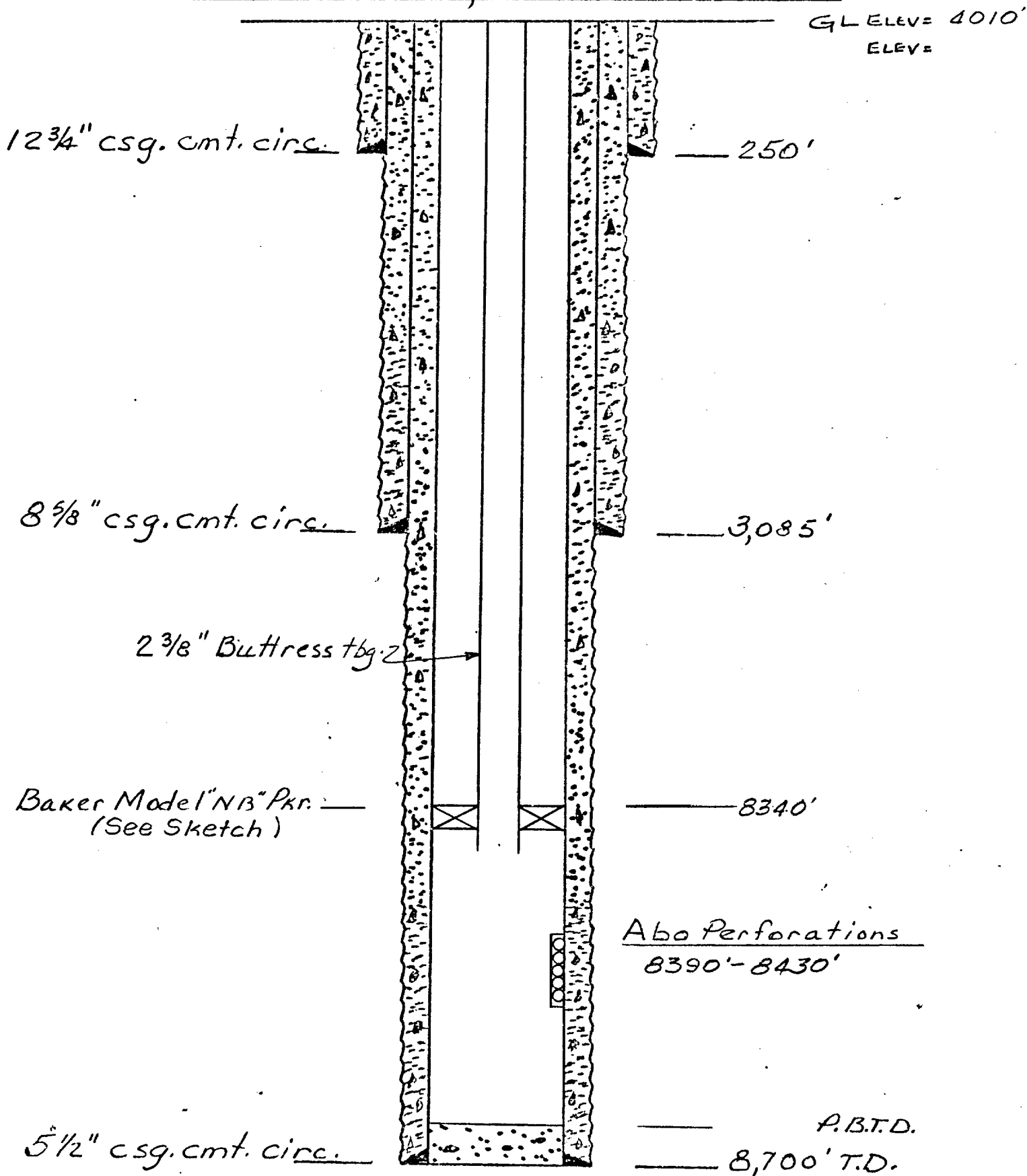

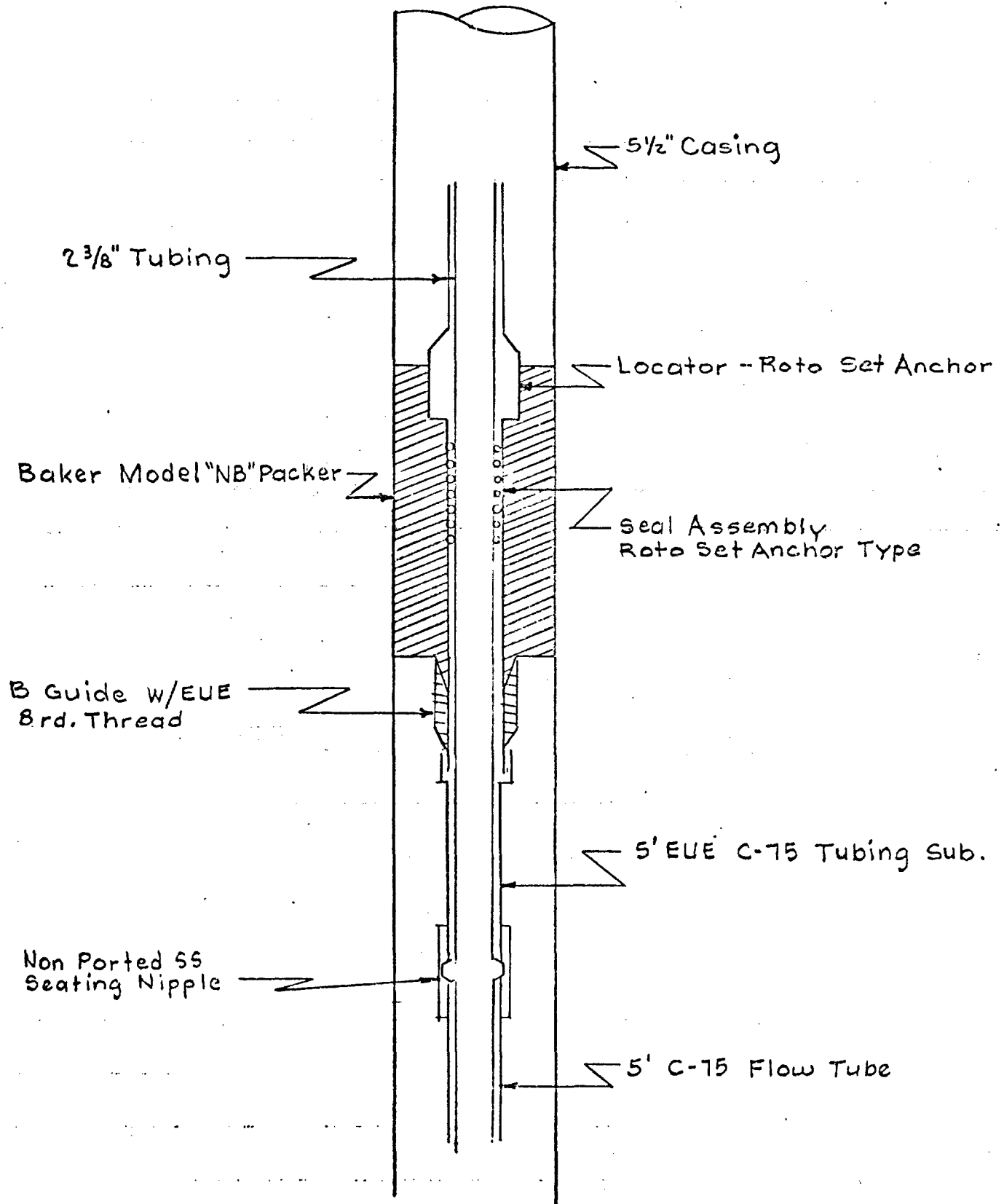
