ADMINISTRATIVE ORDER  
OF THE OIL CONSERVATION COMMISSION

Under the provisions of Order No. R-4430 and R-4430-A, Mobil Oil Corporation has made application to the Commission on May 13, 1974, for permission to expand its North Vacuum-Abo Unit Pressure Maintenance Project in the North Vacuum-Abo Pool, Lea County, New Mexico.

NOW, on this 23rd day of May, 1974, the Secretary-Director finds:

1. That application has been filed in due form;
2. That satisfactory information has been provided that all offset operators have been duly notified of the application;
3. That waivers of objection have been received from such offset operators;
4. That the proposed injection well is eligible for conversion to water injection under the terms of Order R-4430 and R-4430-A.
5. That the proposed expansion of the above-referenced pressure maintenance project will not cause waste nor impair correlative rights; and
6. That the application should be approved.


IT IS THEREFORE ORDERED:

That the applicant, Mobil Oil Corporation, be and the same is hereby authorized to inject water or gas into the Abo formation through the following described well for purposes of secondary recovery, to wit:

North Vacuum Abo Unit Well No. 220, located in Unit P, Section 22, Township 17 South, Range 34 East, NMPM, Lea County, New Mexico.
