Gentlemen:

We respectfully request administrative approval of expansion of waterflood pressure maintenance project, as provided by Order No. R-5897, Rule 9, for the East Vacuum Grayburg/San Andres Unit, pressure maintenance project, to convert East Vacuum Gb/SA Unit Tract 2054, Well No. 003 to water injection service. The following data is submitted in support of this request:

- 1. Unit Plat reflecting the proposed injection well project area (Tract 2054, No. 003--Unit M, Section 20, T-17-S, R-35-E.)
- 2. Borehole Compensated Sonic log of the injection well.
- 3. Diagramatic sketch of the proposed well, injection tubing, packer, and pressure control elements identifying the San Andres perforated injection interval.
- 4. The name of the injection formation is San Andres with injection to be into the well interval as follows: 4590'-4700'. The maximum anticipated injection pressure will be no more than 0.2 psi per foot to the top of the perforation with a maximum daily volume anticipated at 2500 bbls for the identified well.





CONVERSION TO WATER INJECTION STATUS


