THE APPLICATION OF RALPH LONE FOR PERMISSION TO EFFECT CONVERSION TO SALT WATER DISPOSAL OF HIS MARKHAM STATE WELL NO. 2, LOCATED IN THE NW/4 SE/4 OF SECTION 32, TOWNSHIP 11 SCUTH, RANGE 38 EAST, NMPM, LEA COUNTY, NEV MEXICO.

ADMINISTRATIVE ORDER OF THE CIL CONSERVATION CORMISSION

Under the provisions of Rule 701 (c) Ralph Lowe made application to the New Mexico Cil Conservation Commission on January 17, 1958, for permission to convert for salt water disposal, its Markham State Well No. 2, located in the NW/4 SE/4 of Section 32, Township 11 South, Range 38 East, NMPM, Lea County, New Mexico, to facilitate disposal of salt water into the San Andres formation.

The Secretary-Director Finds:

- (1) That application has been duly filed under the provisions of Rule 701 (c) of the Commission Rules and Regulations;
- (2) That satisfactory information has been provided that all offset operators, surface owners, and the New Mexico State Engineer have been duly notified; and
- (3) That the applicant has presented satisfactory evidence that all requirements prescribed in Rule 701 (c) will be met.
- (4) That no objections have been received within the waiting period as prescribed by said rule.

IT IS THEREFORE ORDERED:

That the applicant, herein, Ralph Lowe, be and it hereby is authorized to convert for salt water disposal his Markham State Well No. 2, located in the MAI/4 SE/4 Section 32, Township 11 South, Range 38 East, in such manner as to permit the injection of salt water for disposal purposes into the San Andres formation.

IT IS FURTHER ORDERED, That jurisdiction of this cause is hereby retained by the Commission for such further order or orders as may seem necessary or convenient for the prevention of waste and/or protection of correlative rights; upon failure of applicant to comply with any requirement of this order fter proper notice and hearing the Commission may terminate the authority hereby granted in the interests of conservation. That applicant shall submit monthly eports of its disposal operation in accordance with Rules 704 and 1119 of the Commissions Rules and Regulations.
