THE APPLICATION OF CARPER DRILLING
COMPANY, INC., FOR A SALT WATER
DISPOSAL WELL.

ADMINISTRATIVE ORDER
OF THE OIL CONSERVATION COMMISSION

Under the provisions of Rule 701 (c) Carper Drilling Company, Inc., made application to the New Mexico Oil Conservation Commission on July 31, 1964, for permission to complete for salt water disposal its State "SWD" Well No. 1 located in Unit D of Section 26, Township 12 South, Range 32 East, NMPM, Lea County, New Mexico.

The Secretary-Director Finds:

(1) That application has been duly filed under the provisions of Rule 701 (c) of the Commission Rules and Regulations;

(2) That satisfactory information has been provided that all offset operators, surface owners and the New Mexico State Engineer Office have been duly notified; and

(3) That the applicant has presented satisfactory evidence that all requirements prescribed in Rule 701 (c) will be met.

(4) That waivers of objection from the State Engineer and offsetting operators have been received and the waiting period as prescribed by said rule may be dispensed with at this time.

IT IS THEREFORE ORDERED:


That the applicant herein, Carper Drilling Company, Inc., is hereby authorized to complete its State "SWD" Well No. 1 located in Unit D of Section 26, Township 12 South, Range 32 East, NMPM, Lea County, New Mexico, in such a manner as to permit the injection of salt water for disposal purposes into the San Andres formation at approximately 3710 feet to approximately 5000 feet through 2-3/8 inch tubing with a packer set at approximately 3650 feet in 8-5/8 inch casing.

IT IS FURTHER ORDERED:

That jurisdiction of this cause is hereby retained by the Commission for such further order or orders as may seem necessary or convenient for the prevention of waste and/or protection of correlative rights; upon failure of applicant to comply with any requirement of this order, after notice and hearing the Commission may terminate the authority hereby granted in the interests of conservation. That applicant shall submit monthly reports of its disposal operation in accordance with Rules 704 and 1119 of the Commission Rules and Regulations.
