The Stevens B No. 8 Unit A, Section 12, T-23S, R-36E was authorized as a waterflood injection well per order R-3539 dated October 31, 1968. Since all the direct and diagonal offsets to this well are Len to he he Alex shut-in we believe this should be reclassified to a SWD well.

There are no direct, or diagonal offset wells to McCallister A No. 2 Unit A, Section 24, T-26S, R-36E which was authorized as a pressure maintenance well per order 4026 dated September 10, 1978. We therefore request this well be reclassified to a SWD well.
