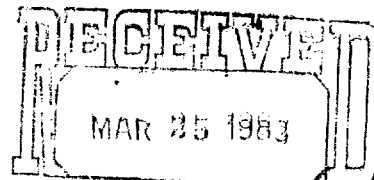

Reference is made to your well No. 5 King Kong, NW $\frac{1}{4}$ SW $\frac{1}{4}$ sec. 4, T. 30 N., R. 17 W., San Juan County, New Mexico, lease No. 14-20-0603-639 and your approved request to convert this well to a water injection well. Approval was granted under the circumstances that existed since the cementing of the 2 3/8" tubing from top to bottom inside the 4 1/2" casing would assure the integrity of the casing, the injected water was not very saline and no fresh water aquifers are in the area.

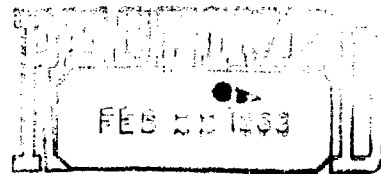
