Re: North Vacuum Abo Unit Well No. 95

Dear Mr. Sweeney:

Reference is made to your request dated April 20, 1989, for authorization to re-utilize the North Vacuum Abo Unit Well No. 95 located 860 feet from the South line and 660 feet from the East line (Unit P) of Section 26, Township 17 South, Range 34 East, NMPM, Lea County, New Mexico, as an Abo injection well in the North Vacuum Abo Unit Pressure Maintenance Project. It is our understanding that the subject well was initially permitted as an Abo injection well by Division Order No. R-4430, dated October 27, 1972, and was subsequently converted to a Devonian salt water disposal well by Order No. SWD-282, dated March 6, 1985.

Inasmuch as the subject well meets all the qualifications for such reclassification, you are hereby authorized to utilize the North Vacuum Abo Unit Well No. 95 for injection into the Abo formation through perforations from approximately 8300 feet to 8650 feet. The packer shall be set approximately 100 feet above the uppermost perforations, and injection shall occur through 2 3/8 inch tubing. Prior to commencing injection operations, the subject well shall be pressure tested from the surface to the proposed packer setting depth to assure the integrity of said casing. The well shall be equipped with a pressure limiting device which will limit the injection pressure to no more than 1660 psi. Operation of the subject well shall be in compliance with the provisions of Division Order No. R-4430 and Rules 702-706 of the Division Rules and Regulations.

Division Order No. SWD-282 is hereby cancelled.
