
Dear Mr. Catanach:


The subject well was approved for salt water disposal by authority of

Dear Mr. Stogner:

The subject well was approved for use as a salt water disposal well by Order No. R-7960 approved June 12, 1985. Said order approved injection into the Devonian formation from approximately 13,474 to 13,564 feet, with disposal water to be lease production only.


In accordance with this order, the Mayme Graham No. 1 was perforated from 13,528 to 13,560 feet and treated with 2,000 gallons acid. The maximum injection rate was 1 barrel per minute at 1800 psi, which is insufficient for use as a water disposal well.

It was entered into the record of Order R-7960 that the surface owner, Mr. John James Motsch, appeared and objected to the use of the subject well as a disposal well and specifically to the disposal of off-lease water.

Enclosed as Exhibit "A" is a statement from Mr. John James Motsch that he has withdrawn this objection and is now in agreement to the use of the Mayme Graham No. 1 as a commercial injection well.

Now therefore, administrative approval is hereby requested to allow injection into the Devonian formation into an open hole interval from 13,600 to 13,900 feet. If said interval is capable of accepting water in sufficient volume, it is requested that permission be granted to utilize said well as a commercial disposal well.
