BTA Oil Producers, 104 S. Pecos, Midland, Texas, 79701, 915/682-3753, Dorothy Houghton, Regulatory Administrator, has applied to the State of New Mexico Energy and Minerals Dept. for a permit to inject produced water into a formation depth which is nonproductive of oil or gas.

The applicant proposes to inject water into the Delaware formation, Grama-B-, 8817 JV-P, Well No. 1. The proposed disposal well is located 660' FSL & 1980' FWL of Sec. 27, T21S, R34E, in a Grama Ridge Delaware field of Lea County, N.M. Water will be injected into strata on the subsurface depth interval of 7504' to 7554' with maximum injection rate of 1000 BWPD and average injection pressure of 1200 psi.

Interested parties must file objections or requests for hearing with the Oil Conservation Division, P.O. Box 2088, Santa Fe, N.M., 87501 within 15 days.
