Pronghorn SWD System has been good enough to furnish us with a copy of the captioned administrative order approved by the Division on October 25, 1993, and signed by the Director. On September 10, 1993, Centennial mailed a letter to the Division protesting the granting of the application and requesting that the matter be set down for a hearing. A copy of this letter is enclosed.

The Centennial partners met with Larry R. Scott and Marc Wise on November 2, 1993 and agreed to settle our concerns as to drainage of Centennial's lease in the SW/4SW/4 of Section 18, Township 19 South, Range 33 East.

This letter is written for the purpose of advising the Division that Centennial no longer protests the Pronghorn application and consents to the approval thereof.


We trust that this letter will clear the record. The well drilled must conform to the Order.



Township 19 South, Range 32 East, Section 24

Gentlemen:

Centennial, a New Mexico General Partnership, has been served with formal notice that Pronghorn SWD System has made application for a water disposal well with the New Mexico Oil Conservation Division; the notice indicates that disposal will be into the Yates-Seven Rivers Formation, open hole, over an interval of 3300' to 3500'. Maximum rate and pressure are anticipated to be 12,500 BWPD and 600 psi. The well is to be located 330' FNL and 1650' FEL of Section 24, Township 19 South, Range 32 East, Lea County, New Mexico.

Centennial owns a federal oil and gas lease, NM NM 81593, described as being Lot 4 (SW4SW4) of Section 18, Township 19 South, Range 33 East, which said tract is located within one-half mile of the proposed SWD Pronghorn #1. It appears from oil and gas maps of the area that there is Yates-Seven Rivers production in the S½N½ of Section 13, Township 19 South, Range 32 East and Centennial is competently advised that there is commercial production of Yates-Seven Rivers oil and gas production in the area north of Centennial's lease in the N½ of Section 18, Township 19 South, Range 33 East.

Centennial protests the granting of the application filed by Pronghorn and states upon information and belief that its opportunity to produce its share of Yates-Seven Rivers oil or gas from its lease will be lost through the sweep of the flood, and its correlative rights will be impaired. Centennial's leasehold is prospectively productive of Yates-Seven Rivers oil and gas in the horizon proposed to be injected.

Centennial requests that this matter be set down for hearing before an examiner and that protestant be notified as to the date.
