Dear Mr. Lemay:

Pronghorn SWD System is requesting that the above referenced order be extended for one year to a new expiration date of October 25, 1995. This order authorizes the drilling and completion of the Pronghorn Federal SWD Well No. 1 at a location in Unit B of Section 24, Township 19 South, Range 32 East, NMMP, Lea County, New Mexico.

The well is intended to serve Pronghorn's existing salt water gathering system and pipeline located in western Lea County. Currently, all of the water accepted for disposal is being transported to Mewbourne Oil Company for beneficial use in their Querecho Plains Bone Springs Unit waterflood. Mewbourne is at this time willing to take all of our available water and thus there is no immediate need to drill the disposal well. This situation will change, however, as the reservoir approaches fillup, and projections are that our well will need to be developed in the next six to nine months.

Other than the timing, there have been no material changes in the information presented in our original application.


Dear Mr. Scott,
