This letter is a written request for an extension, by the Division, for Pendragon Energy Partners' disposal permit (API no. 30-045-30096). The original effective date for the permit was March 13, 2000.

El Paso Field Services (EPFS), the surface owners, raised concerns about the disposal well (located 2220 fsl & 1680 fwl (unit k) of Section 16, Township 26 North, Range 12 West) after it was drilled. Pendragon suspended any further work on the well and is currently in active discussion with EPFS in an attempt to locate the surface facilities in an agreeable location as well as satisfy any other concerns EPFS may have with the operations of the disposal well.

The discussions appear to be coming to a close and Pendragon will complete the well and start injecting produced water as soon as EPFS signs off on a surface agreement.
