

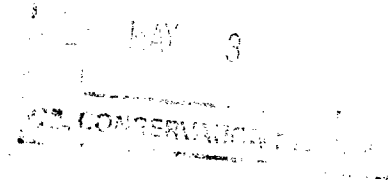

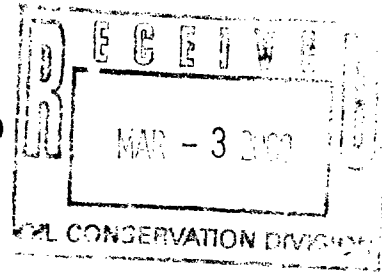

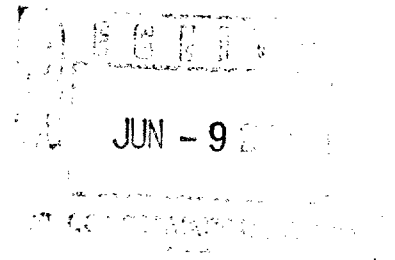

Yates Petroleum Corporation, 105 South Fourth Street, Artesia, NM 88210, has filed form C-108 (Application for Authorization to Inject) with the New Mexico Oil Conservation Division seeking administrative approval for an injection well. The proposed well, the "Exxon New Mexico DH State #1" located 660' FSL & 660' FWL of Section 16, Township 15 South, Range 28 East of Chaves County, New Mexico, will be used for salt water disposal. Disposal waters from the Morrow will be re-injected into the Mississippian/Devonian at a depth of 9392-10,000 with a maximum pressure of 5000 psi and a maximum rate of 10,000 BWPD.

Administrative Order SWD 775 dated May 16, 2000, approves produced water disposal into the Mississippian/Devonian formations in an openhole interval approximately 9392'-10,600' in the Exxon New Mexico DH State Well No. 1 (API No. 30-005-61963) located 660' FSL and 660' FWL of Section 16, T. 15 S., R. 28 E., N.M.P.M., Chaves County, New Mexico.

Re-entry work on the well was recently started. However, subsequent to the C-108 approval the well name was changed and Yates Petroleum Corporation permitted it as the Windmill ATI State #3 (SWD). We now request that this name change be made in the C-108 file so that all records will be consistent.
