The above-named company is hereby authorized to commingle Fulcher Kutz-Pictured Cliffs (Gas – 77200), Angels Peak-Gallup Associated (Associated – 02170), and Basin-Fruitland Coal (Gas – 71629) Pool production from the above mentioned lease and to determine production by separately metering the production from each well prior to commingling. Oil production will not be commingled. Fuel gas usage will be allocated equally between the wells.

NOTE: This installation shall be installed and operated in accordance with the applicable provisions of Rule 303 of the Division Rules and Regulations and the Division "Manual for the Installation and Operation of Commingling Facilities." It is the responsibility of the producer to notify the transporter of this commingling authority.

REMARKS: The commingled natural gas production shall be delivered to a gas sales meter located in the SW/4 of Section 23, Township 27 North, Range 10 West, NMPM, San Juan County, New Mexico.
