Dear Mr. Boneau:

EIGHT Your letter requesting off-lease measurement of natural gas from ~~four~~ of your Pecos Slope Abo Field wells has been reviewed. Because of the special circumstances involved in allowing a gas transmission line hook-up of these wells, which might not otherwise be able to produce, we find your request reasonable and just.

In order to permit these wells to be produced, thereby preventing waste and protecting correlative rights, the proposed off-lease gas measurement for the subject wells is approved subject to the following conditions:

1. All flow lines shall be maintained in a safe and adequate condition and any leaks or failures must be reported to the Division.
2. All separation and liquid storage facilities shall be located on the originating lease.
3. The meters shall be read and maintained by the gas purchaser.
4. Federal and State approval is required where applicable.

In addition, all production, storage, transportation, sales and other operations shall comply with Division Rules and Regulations. A list of the approved wells is attached. Should you have any questions concerning this matter, please contact Gilbert Quintana at 827-5807.
