REQUEST FOR APPROVAL OF OFF-LEASE STORAGE-GOODWIN NO. 1
1980' FNL & 660' FWL OF SECTION 30, T18S, R37E, LEA COUNTY,
NEW MEXICO. GOODWIN DRINKARD POOL.

Conoco Inc. respectfully requests approval to store production from the Goodwin lease at the State GG30 battery in accordance with Rule 309-C of the State of New Mexico Oil Conservation Division rules and regulations.

Conoco Inc. proposes to lay a flowline, approximately 2600 feet, from the Goodwin lease to the State GG30 battery (See Exhibit 1). Conoco Inc. intends to store the Goodwin production in a separate tank, therefore there will be no commingling of production from the two leases (See Exhibit 2).

Conoco Inc. requests approval off this off-lease storage due to the fact that the nominal production of the Goodwin lease, approximately 2 BOPD and 2 BWPD, does not economically justify the Goodwin battery's maintenance cost.

In accordance with Rule 309-C, all parties owning an interest in the two leases have been notified by certified mail and Conoco Inc. will forward proof of receipt of such notification. Also in accordance with Rule 309-C, Conoco Inc. has also made an application for administrative approval to the Director of the Oil Conservation Division, State of New Mexico.

Attached are copies of the notification that has been sent to all interest owners and the \$30 application fee as well as a copy of the application made to the Director of the Oil Conservation Division.
