
Concerning the above referenced well, we are requesting permission to surface commingle this recompletion to the Strawn zone into the Conoco, Inc., SEMU "BMT" battery located in the NW/4 SW/4 of Section 20, T20S, R38E, NMPM, Lea County, New Mexico.

The SEMU "BMT" battery currently has a Commingling Order PLC-67 which allows commingling of the Warren-McKee (oil-63270), Warren-Tubb (oil-63280), Blinebry Oil & Gas (oil-06660), and the East Skaggs-Abo (oil-56630) pools (copy of order attached). The SEMU, Well #114 was drilled and completed as a water injection well for the SEMU McKee waterflood in 1981. In November 1993 it was temporarily abandoned in the McKee with a CIBP set above McKee @ 8850.

The gravity of the Strawn pool in this area is approximately 36.5, and is sweet crude. We do not believe the added Strawn production would adversely effect the gravity of the "BMT" battery crude. The anticipated commingled production will be measured prior to commingling for sales, through a three phase heater treater where the oil, water and gas will be separated. The gas will separately metered for sales. The oil will be measured with a positive displacement meter, and the water will be measured with a turbine meter.

Copies of this commingling request have been sent this date to the working interest owners (listing attached) as well as the royalty interest owners. I have enclosed copies of the area map, battery diagram and listing of the SEMU and Burger B-20 wells going into this facility. 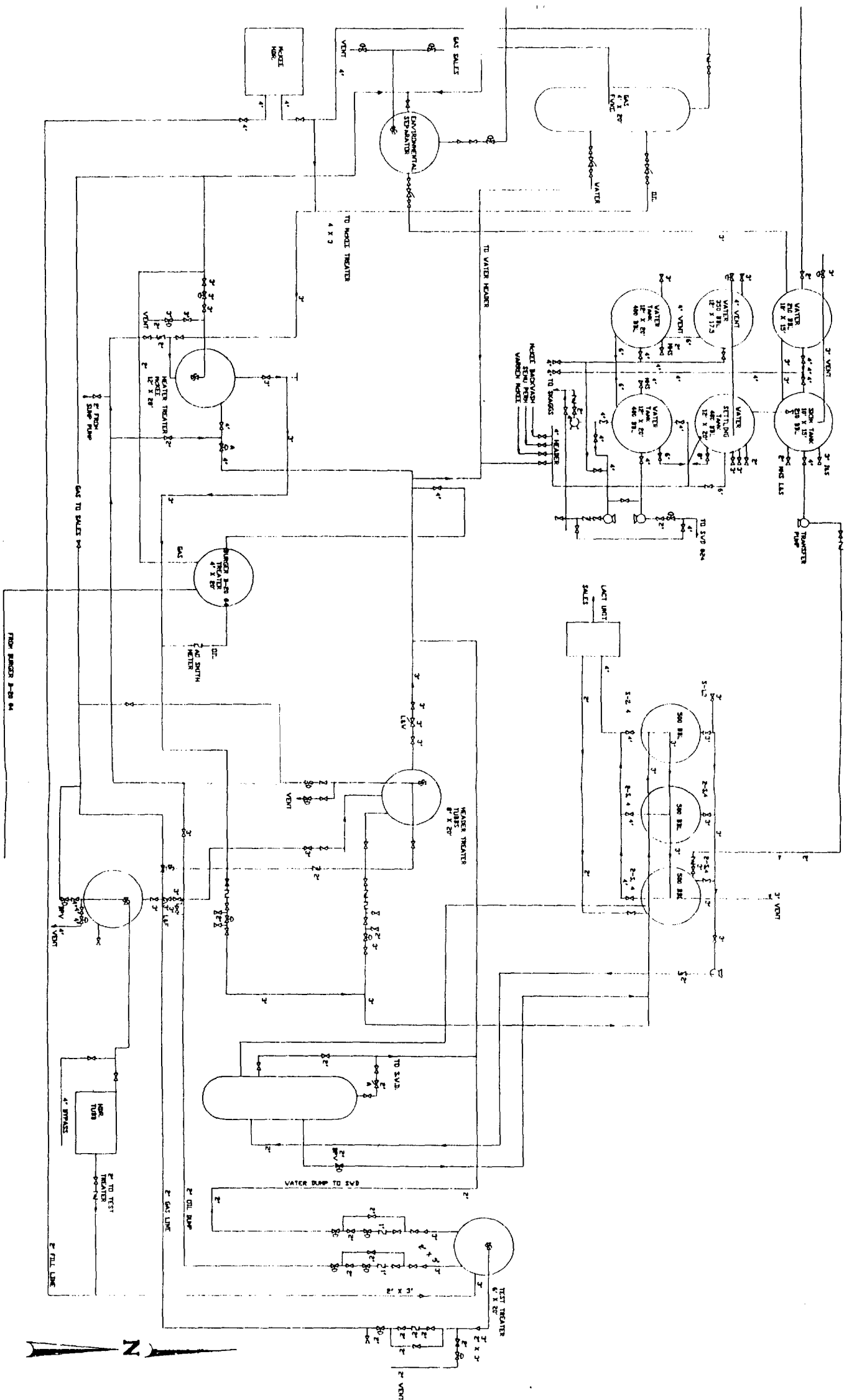

I also needed to respond to your question about the Strawn. The re-completion is proposed for the Strawn, requiring 160 acres. Kay Maddox obtained an exception by Administrative Order NSL-4559 for approval to recomplete from the McKee to the Strawn. Within the order it states "The NW/4 of Section 29, being a standard 160 acre oil spacing and proration unit within the governing limits of the North Hard-Strawn Pool, is to be dedicated to this well."
