COMMINGLING ORDER CTB-382

Barber Oil, Inc. P.O. Box 1658 Carlsbad, NM 88220

Attention: Michael D. Garringer

The above named company is hereby authorized to commingle Barber Yates Pool production from the following leases in Eddy County, New Mexico.:

Lease:	Colglazier Well Nos. 1, 2, and 3
Description:	W/2 NE/4; and,

Lease:Stovall-Wood Well Nos. 1, 2 and 3Description:E/2 NW/4,

Both in Section 20, Township 20 South, Range 30 East, and

Lease:State "B" Well No. 2Description:SE/4 SW/4, and;

Lease: State "A" Well Nos. 1 and 4-A Description: W/2 SE/4,

Both in Section 17, Township 20 South, Range 30 East.

Due to the marginal nature of hydrocarbon production and the longevity of operation in the subject leases, production shall be allocated to each lease based on well test conducted on October 14, 1993 and historical production data for all the leases. Calculations using these data result in the following production percentages:

Colglazier Federal Lease	22%
Stovall-Wood Fee Lease	44%
State "B" Lease	16%
State "A" Lease	18%.

These allocations shall be confirmed by annual well tests, witnessed by a Division representative. Allocation percentages may be adjusted as necessary, subject to like approval by all royalty interest owners concerned as well as the New Mexico Oil Conservation Division.

NOTE: This installation shall be installed and operated in accordance with the applicable provisions of Rule 303 of the Division Rules and Regulations and the Division "Manual for the Installation and Operation of Commingling Facilities." If is the responsibility of the producer to notify the transporter of this commingling authority.

FURTHER: The operator shall notify the Artesia District Office of the Division prior to implementation of the commingling process.

REMARKS: Commingled production shall be stored in the tank battery located in Unit Letter C of Section 20, Township 20 South, Range 30 East, NMPM, Eddy County, New Mexico.
