ARCO Oil & Gas Company requests approval for surface commingling of oil production from the recently completed Duthie Andrews Federal No. 1 with other Langlie Mattix oil production from ARCO's 280 acre Duthie Andrews WN lease.

The oil is from the same reservoir, and the price received will not be reduced because of commingling. Accurate measuring facilities will be installed to assure proper credit for oil sales. A diagrammatic sketch of the proposed surface facilities is attached to the enclosed Application to Commingle which is being filed with the New Mexico Department of Minerals and Energy. Oil from the Duthie Andrews Fed #1 will be measured through a one barrel positive displacement vessel with a recording counter. Each one barrel dump of the meter will be recorded on a mechanical counter and this will provide a record of the oil produced from the lease for purposes of allocating sales volumes to this well.

The purpose of surface commingling is to reduce the investment and operating cost of the production facilities for the subject well. This will permit ARCO to recover more reserves before the well reaches its economic limit. This, in turn, will result in more revenue to the lease, to be divided between the operator and royalty owner.




