RE: Southland #1, #3, & #4
Pictured Cliffs Gas Wells

Gentlemen:

We have drilled three small shallow gas wells located as follows:

Southland #1 - 1340' FSL & 1340' FWL, Sec. 3, T26N, R13W;
Southland #3 - 790' FNL & 1450' FWL, Sec. 10, T26N, R13W;
Southland #4 - 790' FNL & 790' FWL, Sec. 9, T26N, R13W.

This is on a farmout from Southland Royalty, all on the same lease with common ownership of royalty, overriding royalty, and working interest. We estimate produced volume to be 50 MCF/day per well.

Because of the extremely lengthy delays in obtaining right-of-ways from the Navajo Tribe we propose to lay a temporary gathering system connecting these three wells and tying into the gas purchaser, El Paso Natural Gas Company's meter nearby our Chaco #7 located in the SW/SW Section 1, T26N, R13W. The proposed line is shown dotted in red on the enclosed map. We propose to allocate production between these wells by producing two wells with the third well shut in and doing this with each well, thereby establishing a percentage of total gas sales for each well. We have executed a Gas Purchase Agreement with El Paso Natural Gas Company. We request administrative approval to expedite this work and request that if you have any questions you contact us at the above telephone number.

This proposed gathering will be replaced by a normal gathering system with individual well meters at such time as El Paso receives right-of-way approval.

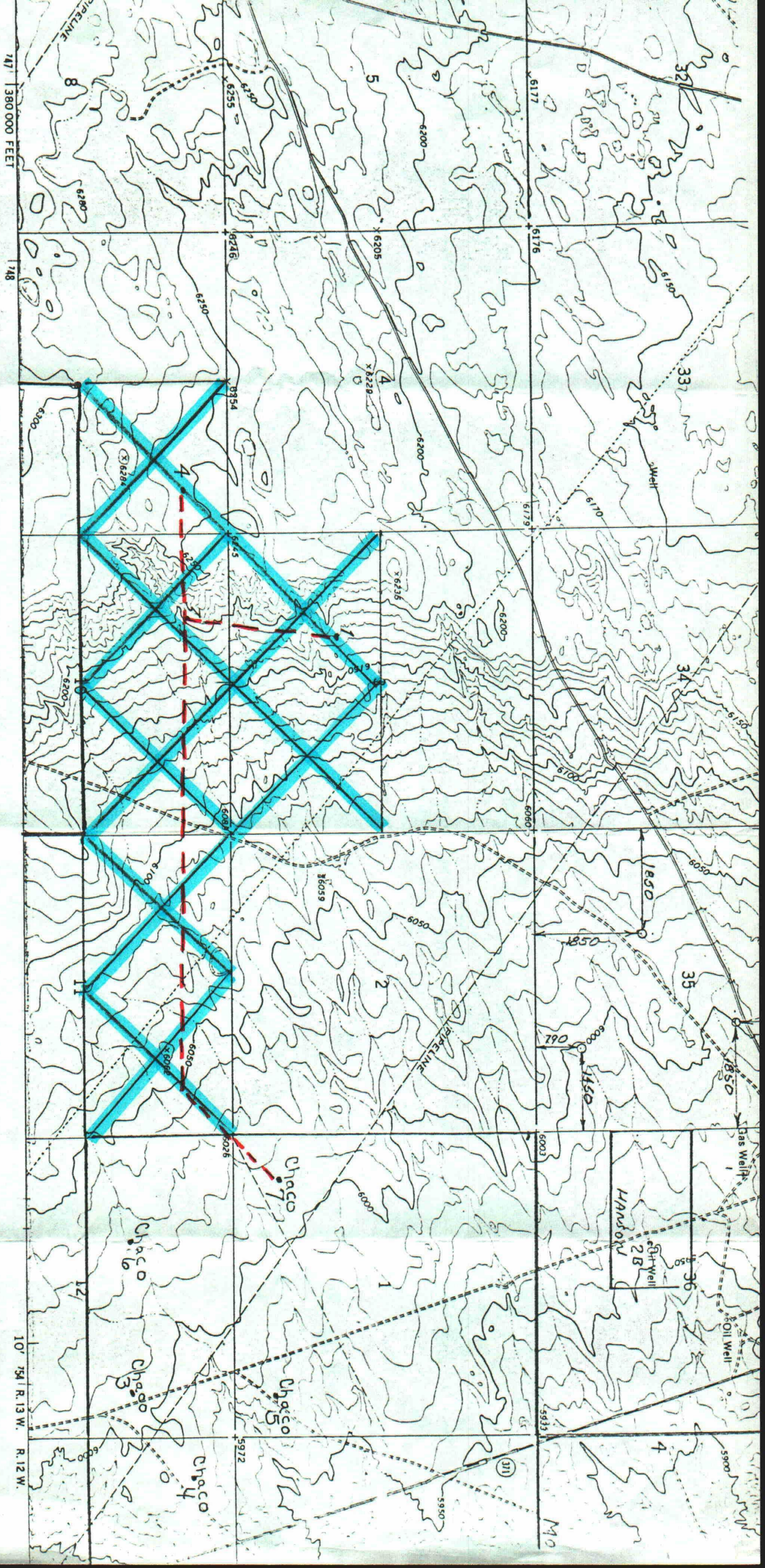
