Southwestern Energy Production Company ("SWN") has received notice that Duke Energy Field Services, LP has requested permission to drill an acid gas injection well within 1/2 mile of SWN's Leatherstocking "18" State Com #1 well Located 1310' FNL & 1310' FWL of Section 18-18S-28E, Eddy County, New Mexico. While SWN recognizes that the Duke proposal is for injection in the Devonian Formation SWN is concerned about maintaining wellbore integrity in its Leatherstocking well by avoiding any possibility of sour gas encroachment from the operation of the captioned Duke AGI well..

SWN hereby voices its objection to the proposed Duke injection well until we have had sufficient time to quantify the potential liability of the Duke well; therefore SWN respectfully requests a hearing on the matter.
