Dear Mr. Bedingfield:

Reference is made to your letter of June 6, 1963, wherein you have requested authority for off-lease storage for your Hastie Federal Lease in the NW/4 of Section 18, Township 17 South, Range 28 East. It is our understanding that you would move this oil to your Sunray State Lease in the SW/4 NW/4 of Section 30, Township 17 South, Range 28 East, and there measure and store it in a separate tank battery.

We have now received copy of letter from the United States Geological Survey in which they give their consent to this proposal.

Pursuant to the authority granted me pursuant to Rule 309-C, you are therefore, hereby authorized the off-lease storage as outlined above. Provided however, that there shall be no intercommunication of the separating, handling, treating, or storage facilities designated to these leases.
