Gentlemen:

Reference is made to your letter dated July 17, 1964, wherein you request authority for off-lease storage for your W. A. State Lease comprising the NW/4 of Section 32, Township 9 South, Range 33 East, Flying "M" Pool, Lea County, New Mexico.

It is our understanding that the tank battery for said W. A. State Lease will be located in the SW/4 NE/4 of Section 29, Township 9 South, Range 33 East, on your Gonzales Federal Lease, and that there will be no inter-communication of the handling, separating, treating, or storage facilities designated to the W. A. State Lease with that of any other lease.

Pursuant to the authority vested in me by Rule 309-C of the Commission Rules and Regulations, the aforesaid off-lease storage is hereby authorized.

Coastal States is requesting administrative approval for off-lease storage for their W. A. State and Sinclair State leases in the Flying "M" (San Andres) Field of Lea County, New Mexico. The leases involved are state leases located in Sections 20 and 32, T-9S, R-33E.


As outlined in Rule 309-C, all partners owning an interest in these leases have been notified and copies of the registered letter receipts are attached. Also attached are copies of letters sent to each owner involved, and a plat of the area.

All production will be from the same common source; commingling will not result, and there will be no inter-communication of the handling, ^{separating} ~~spearating~~, treating, or storage designated to each lease. The tank battery storage for these leases will be located in the approximate center of Section 29.
