Gentlemen:

Your telephone call of December 28 requests approval for off-lease storage of the oil and gas production from your well No. 1 Jones Federal E in the SE $\frac{1}{4}$ NE $\frac{1}{4}$ sec. 23, T. 19 S., R. 31 E., in a tank battery to be located in the NE $\frac{1}{4}$ SW $\frac{1}{4}$ sec. 24, T. 19 S., R. 31 E., N.M.P.M.

Office records show that the E $\frac{1}{2}$ sec. 23 and the W $\frac{1}{2}$ sec. 24, T. 19 S., R. 31 E., are both covered by Federal lease New Mexico 0107697.
