Gentlemen:

Reference is made to your application dated June 21, 1972, for an exception to Rule 309-A of the Commission Rules and Regulations to permit off-lease storage for Shugart Pool production from your Ginsberg Federal Wells Nos. 12, 13, and 14, located in Units O, G, and B, respectively, of Section 26, Township 18 South, Range 30 East, Eddy County, New Mexico. It is our understanding that this production is to be handled in a separate tank battery located on your Louise B. Benson Lease in Unit J of Section 26.

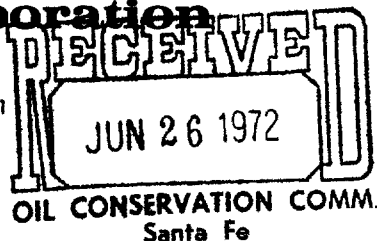

We therefore request Administrative approval for this off-lease storage as per Rule 309C.

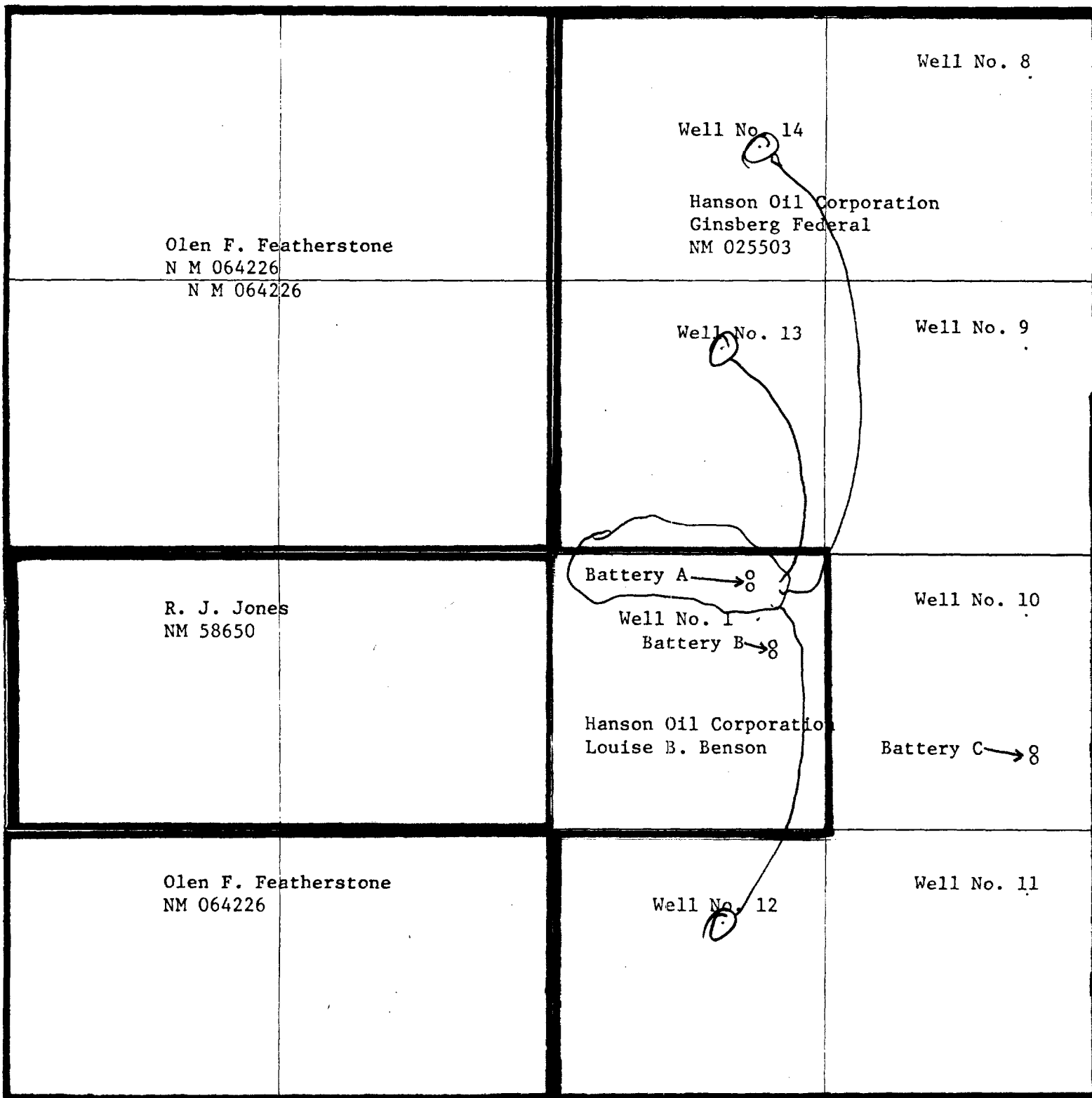




Gentlemen:

Your letter of June 6, 1972 requests approval for off-lease storage of Queen-Grayburg production from oil and gas lease New Mexico 025503 involving three wells in sec. 26, T. 18 S., R. 30 E., N.M.P.M., Eddy County, New Mexico.
