Reference is made to your application for an exception to Rule 309-C of the Commission Rules and Regulations to permit off-lease storage for the producing wells on your Dekalb lease NM04393, located in the SE/4 of Section 31, Township 16 South, Range 30 East, NMPM, Square Lake Pool, Eddy County, New Mexico.

Pursuant to the authority granted me by Rule 309-C, you are hereby authorized off-lease storage for the above-described production, to be handled in a separate tank battery located near your water storage and injection station in the SW/4 of Section 31, Township 16 South, Range 30 East, NMPM, provided that there shall be no intercommunication between the handling, separating, treating, and storage facilities designated to the Dekalb lease and those of any other lease.

Gentlemen:


We would like to request an exception to Rule 309-C for your approval of off-lease storage for our Dekalb lease NM 04393, SE $\frac{1}{4}$ Section 31, T16S, R30E in the Square Lake pool Eddy County, N. M., comprising four wells in the Grayburg formation, two of which are shut-in injection, and two are production.

We would set a separate tank battery and treating system so these wells would ~~be completely separate from the battery and gathering system now in use for our co-mingled Etz and Federal E leases.~~ The tank battery would be adjacent to our present produced water storage and injection pump so that produced water could be put into our present injection system, which is also on Federal lease. The off-lease storage and injection of produced water has been verbally approved by USGS with a request for written approval already in their hands.

The Dekalb lease has 75% WI and 7 $\frac{1}{2}$ % ORRI equally divided between C. E. LaRue and B. N. Muncy, Jr., and carries an additional 5% ORRI divided among the following persons in stated interests, with all persons being notified at their last known address by certified mail:
