Dear Mr. Porter:

Humble respectfully requests Administrative Approval for an Exception to Rule 303(a) to permit the commingling in common facilities from the Caudill (Wolfcamp) Field with production from the Caudill (Devonian) Field on our D. H. Crockett Lease. The Crockett Lease contains 240 acres and is described as the NE/4 and E/2 of the NW/4 of Section 21, T-15-S, R-36-E, Lea County, New Mexico, and is owned 100% by Humble.

At the present time the Crockett No. 1 is completed in the Devonian Formation and produces 60 barrels of oil per day. The corrected gravity of this oil is 57.5° API and is purchased by Gulf Oil Corporation under their West Texas Segregated Intermediate price of \$2.79 per barrel. The Crockett No. 2 is completed in the Wolfcamp Formation and has an allowable of 155 barrels of oil per day. The corrected gravity is 41° API and is also purchased by Gulf Oil Corporation under their West Texas Segregated Intermediate price of \$3.01 per barrel.

The gravity of the commingled product would be approximately 46° API and would receive a price of \$2.97 per barrel. This price would represent an increase of approximately \$13 per day.

At the present time the production from each reservoir is produced and sold from one 500 barrel tank. This procedure requires the wells to be shut in while a pipe line run is being made from the lease. Since Well No. 1 is incapable of top allowable, production is lost during pipe line runs.

In support of this application we are attaching a lease plat showing the proposed commingling, and a schematic diagram showing the individual equipment. The production from each of the zones will be separately metered thru individual positive displacement type meters prior to commingling. In addition, the production from each reservoir will be separately reported to the Commission on Form C-115.

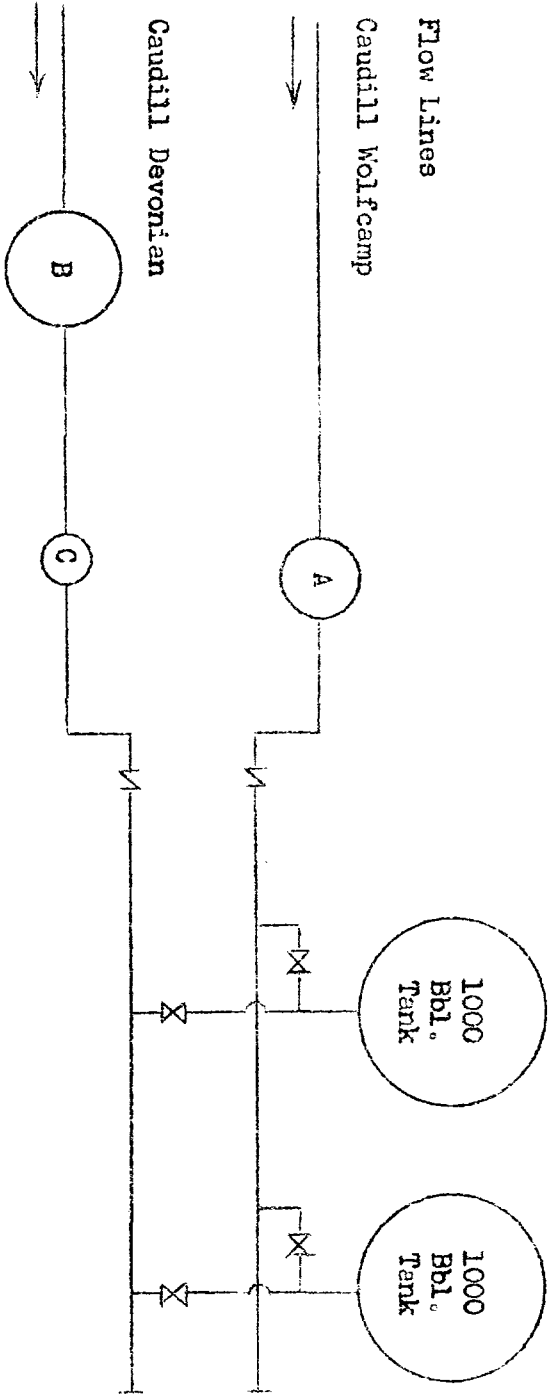


