Gentlemen:

This is to advise that certain wells completed in the Blinetry Zone on TEXACO Inc.'s G. L. Erwin "a" Lease, comprised of the SW/4 of Section 35, Township 24 South, Range 37 East, Lea County, New Mexico, are capable of producing top allowable following recent re-stimulation remedial work. Notification of the producing capabilities is in accordance with Amendment, Administrative Order PC-82, amended October 9, 1964.

Administrative Order PC-82, as amended, authorized commingling production, without separate measurement, from the Tubb Drinkard, Devonian and Blinetry Zones on the subject lease since no well on the lease was capable of producing top allowable prior to the amendment. Subsequently, the aforementioned remedial work was performed.

Since only one of the three zones contain wells capable of producing top allowable, it is respectfully requested that Administrative Order PC-82 be further amended to authorize commingling after separately metering the total Blinetry production and using the subtraction method for determining the Tubb Drinkard and Devonian production. The gravity of the liquid hydrocarbon production from each zone is below 45° API.



Gentlemen:

Your letter of December 23, 1964, requests approval to modify the commingling system, lease Las Cruces 032874(a), approved by our letter of October 15, 1964. Since certain Blinebry wells have been re-worked and are capable of producing top allowable, you now propose to separately meter oil production from the Blinebry in the SW $\frac{1}{4}$ sec. 35, T. 24 S., R. 37 E., N.M.P.M. and allocate production from the Tubb-Drinkard and Devonian on the basis of periodic well tests.

The method of commingling as proposed in your letter of December 23 is hereby approved.
