Administrative Order PC-111, as amended, provides for commingling of the Weir Blinbry, Weir Drinkard, and Monument-Tubb production on our Gillully "B" Federal Lease with production being allocated on the basis of periodic well tests.

Approval to commingle the Monument-Grayburg San Andres (GSA) was originally authorized by your letter of November 2, 1962. However, the Monument-GSA was deleted by an amendment to Administrative Order PC-111 dated January 23, 1969, upon Amoco's request.

In September, 1980, the Monument-GSA on the Gillully "B" Lease was returned to production in the commingled battery. Amoco inadvertently overlooked requesting that Administrative Order PC-111 be amended again to include the Monument-GSA Pool. Amoco hereby requests an amendment to Administrative Order PC-111 to include the Monument-GSA Pool in the commingling installation.

The value of the production has not been significantly affected by commingling all four pools, and none of the pools produce more than top allowable. The ownership is common for all pools.

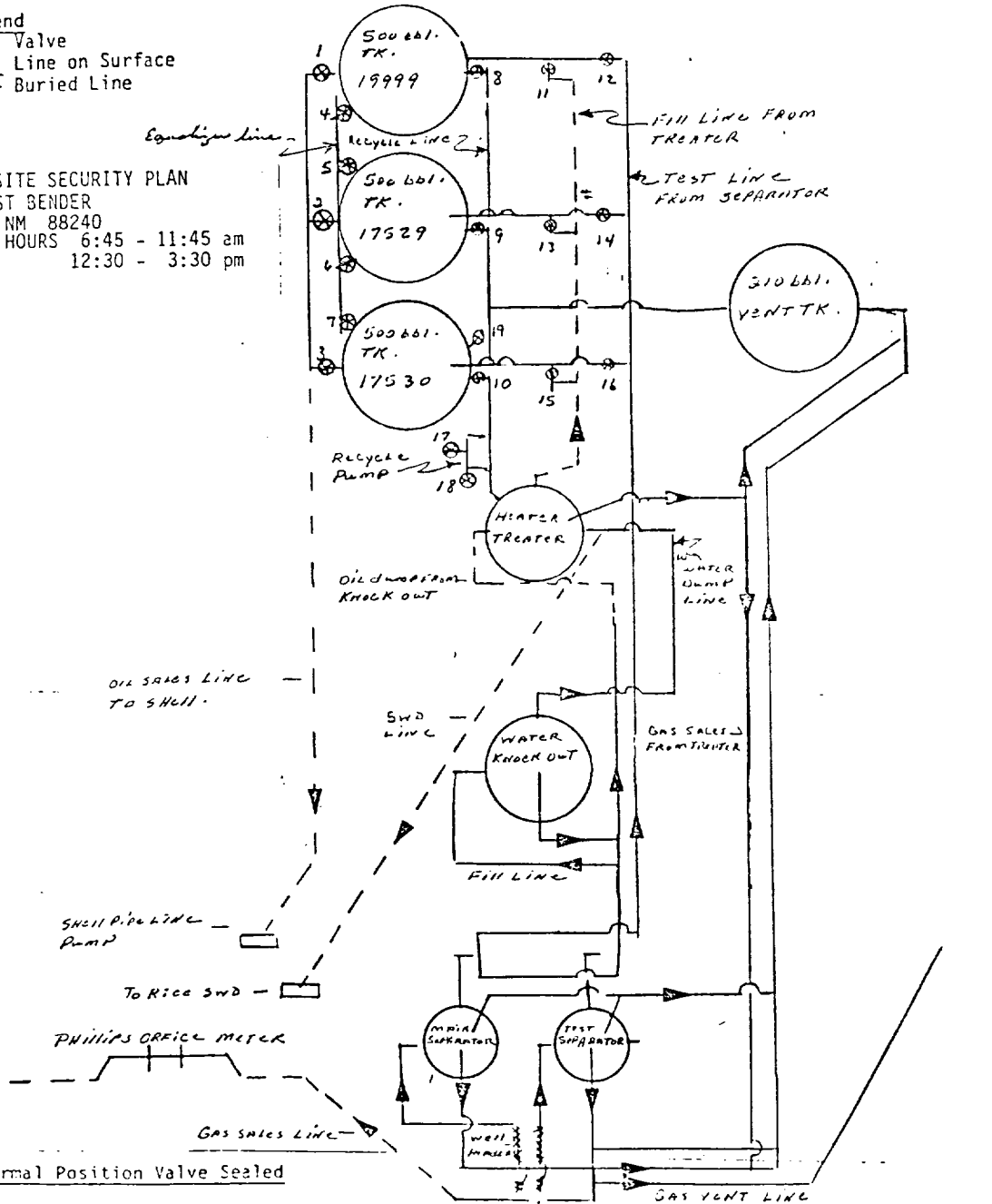
