Tidewater Oil Company respectfully submits this application for administrative approval to commingle oil production from the Justis Tubb-Drinkard Pool with oil from the Justis Blinebry Pool on its G. D. Riggs "B" lease in accordance with Rules 303 and 309-B of the New Mexico Oil Conservation Commission Rules and Regulations as revised by NMOCC Order No. R-2060.

In support of this application, Tidewater Oil Company wishes to state the following:

- 1. Tidewater Oil Company's G. D. Riggs "B" lease is located in Sec. 1, T26E, R37E, Lea County, New Mexico.
- 2. Attached is a table listing the present gravities, values thereof, composite gravity, value thereof, daily volume and daily revenue increase.
- 3. The expected commercial value of the commingled production will be more than the commercial value of the present production by approximately \$156 per day.
- 4. Attached is a diagrammatic sketch of the proposed installation.
- 5. Attached is a plat showing the location of all wells on the above lease.
- 6. Tidewater has furnished the U.S.G.S., as interest owner, a copy of the attached plat and sketch with a letter of request for approval. Tidewater has secured U.S.G.S. approval as per attached letter.


