#### Gentlemen:

Reference is made to your application dated June 24, 1963, for administrative approval of an exception to Rule 303 (a) of the Cemmission Rules and Regulations to permit the commingling of oil production from the Skaggs-Glorieta, Skaggs-Drinkard, East Weir-Blinebry, and the Eumont Pools and the distillate production from the Eumont Pool on your Skaggs B-12 Lease comprising the HW/4 HE/4 and N/2 NW/4 of Section 12, Township 20 South, Range 37 East, Lea County, New Mexico, after separately metering the Glorieta, Blinebry, and Drinkard production and allocating the Eumont oil and distillate production by means of the subtraction method and periodic tests.

You are further requested to notify the Hobbs District Office of the Commission upon completion of this installation so that a field inspection may be made prior to putting the installation in operation.
