Gentlemen:

Continental Oil Company respectfully requests administrative approval under the provisions of Rule 303, as amended by Order R-2060, to commingle production from three pools underlying the State H-35 Lease which consists of the NE/4 and the E/2 of the NW/4 of Section 35, T17S, R34E, Lea County, New Mexico Wells and Pools to be commingled are as follows:

Vacuum Abo Well No. 7 (dual)
Vacuum Wolfcamp Well No. 7 (dual)
Vacuum Glorieta Well No. 8

In support of this request, we should like to point out that the proposed facility is in accordance with the applicable provisions of the Commission's "Manual for the Installation and Operation of Commingling Facilities", now current, and Rule 303(b) as follows:

- 1. Ownership of all zones in common.
- 2. The facility is in substantial compliance with the installation depicted on Figure 3 in the manual as illustrated on the attached schematic drawing of the proposed installation.
- 3. Production from each zone to be commingled will be separately measured by means of meters acceptable to the Commission. Positive volume dump type meters will be used to meter individual zones and will be equipped with non-reset counters.
- 4. A common test vessel will be utilized with automatic well test headers controlled such that only one well from any one zone may be tested at any one time. The bad oil return system will also utilize the common test vessel and will be designed so that wells cannot be tested while bad oil is being returned.
- 5. BS&W content will be periodically determined by the standard centrifugal testing procedure. Meters are to be proved monthly by means of a strapped storage tank.

6. The value of the commingled crude will be enhanced through commingling as indicated by the following data:




