AMENDMENT

Administrative Order PC-241

Gentlemen:

Reference is made to your letter dated April 1, 1968, wherein you request an amendment to Administrative Order PC-241 which order, dated November 5, 1964, authorizes the commingling, after separate metering, of Fowler-Blinbry and Fowler-Devonian production on your Myers "B" Federal Lease comprising the S/2 of Section 9, Township 24 South, Range 37 East, Lea County, New Mexico. It is our understanding that all production on this lease is now of marginal nature and that you wish to commingle, allocating the production on the basis of periodic well tests.

Administrative Order PC-241 is hereby amended to delete the metering requirement, provided however, that you shall notify the Commission at such time as any well in either of the zones is capable of top allowable production.

Gentlemen:

Administrative Order PC-241 dated November 5, 1964, authorizes the commingling, after separately metering, the production from the Fowler Blinebry and Fowler Devonian Oil Pools on our Myers "B" Federal (R/A A) Lease, comprising the S/2 of Section 9, T-24-S, R-37-E, Lea County, New Mexico.

The wells are marginal and are incapable of producing their top unit allowable. Attachment I reflects the production for January and February for each well in each pool.

In view of the above, we propose that Administrative Order PC-241 be amended to provide for commingling without separately measuring the production from each zone. Pool and well production to be allocated on a well test basis which is to be taken periodically. Attachment II is a schematic of the proposed installation.

Attachment III is a plat reflecting the relative location of the wells, and lease.

There is no diversity of ownership between zones of the lease.
