Gentlemen:

In accordance with New Mexico Oil Conservation Rule 303-B, TEXACO INC. respectfully requests permission to commingle the liquid hydrocarbon production from the Wantz Granite Wash Pool with the presently commingled Blinebry Oil, Blinebry Gas, Tubb Gas, Tubb Oil and Drinkard Pools.

TEXACO is in the process of completing the A. H. Blinebry Federal (NCT-1) Well No. 38, located in Section 19, Township 22 South, Range 38 East, Lea County, New Mexico, in the Drinkard and Wantz Granite Wash Pools. This is the only well on the A. H. Blinebry (NCT-1) Lease producing from the Wantz Granite Wash Pool. The subject well is capable of producing top allowable from both the Drinkard and Granite Wash Pools; therefore, all Drinkard and Granite Wash production will be metered.


The gravity of the Drinkard, Blinebry and Tubb crude is 41.50 API with a value of \$12.56 per barrel. The gravity of the Wantz Granite Wash crude is 38.40 API with a value of \$12.56 per barrel. The expected gravity of the commingled crude is 40.50 API with a value of \$12.56 per barrel and no change in the actual commercial value of such commingled production.

A schematic diagram of the proposed commingling installation and plat of the subject lease are attached.

Texas New Mexico Pipeline Company as purchaser of crude production and USGS are being furnished a copy of this application.

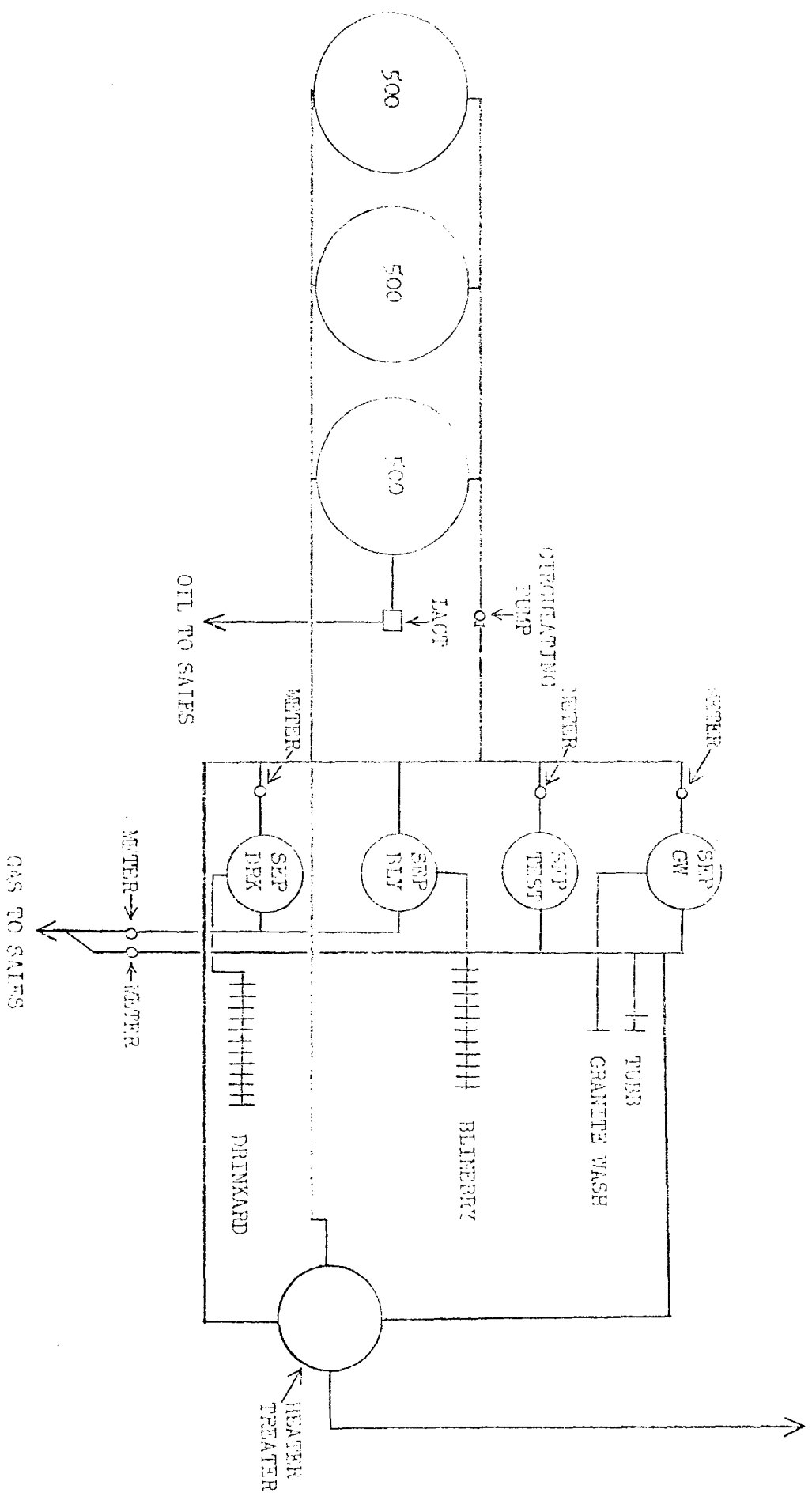

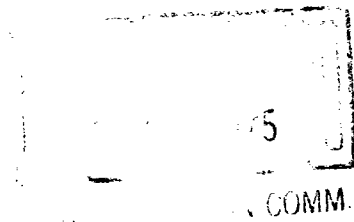

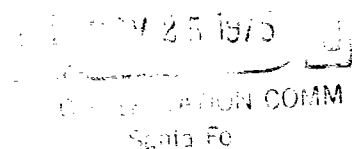
