Gentlemen:

Sinclair Oil & Gas Company requests an exception to Rule 303 and administrative approval to commingle the oil produced from the Justis Blinebry Pool, the Justis Tubb-Drinkard Pool, the Justis Fusselman Pool and the Justis Montoya Pool on the Wimberly WN lease in Section 23 and 24, Township 25 South, Range 37 East. All wells are commonly owned.

The Blinebry and Fusselman zones have some wells that are capable of top allowable production while the Tubb-Drinkard and Montoya wells are physically incapable of producing top allowable. It is requested that approval be granted to commingle by separately metering the Blinebry and Fusselman crudes and by determining the Montoya and Tubb-Drinkard production by the subtraction method and periodic well tests.


The API gravities and the respective values of the oils are shown below:

ZONE	API GRAVITY	VALUE PER BARREL
BLINEBRY	37.8	\$2.95
TUBB-DRINKARD	37.0	\$2.95
FUSSEIMAN	37.5	\$2.95
MONTOYA	35.3	\$2.91

The gravity of the commingled production is expected to be 37.5° API with a value of \$2.95 per barrel which is not less than the sum of the individual crude values.

Attached is a plat and schematic diagram showing the location of all wells, the pools from which each well produces, the proposed tank battery arrangement and a letter of approval from Texas-New Mexico Pipe Line Company

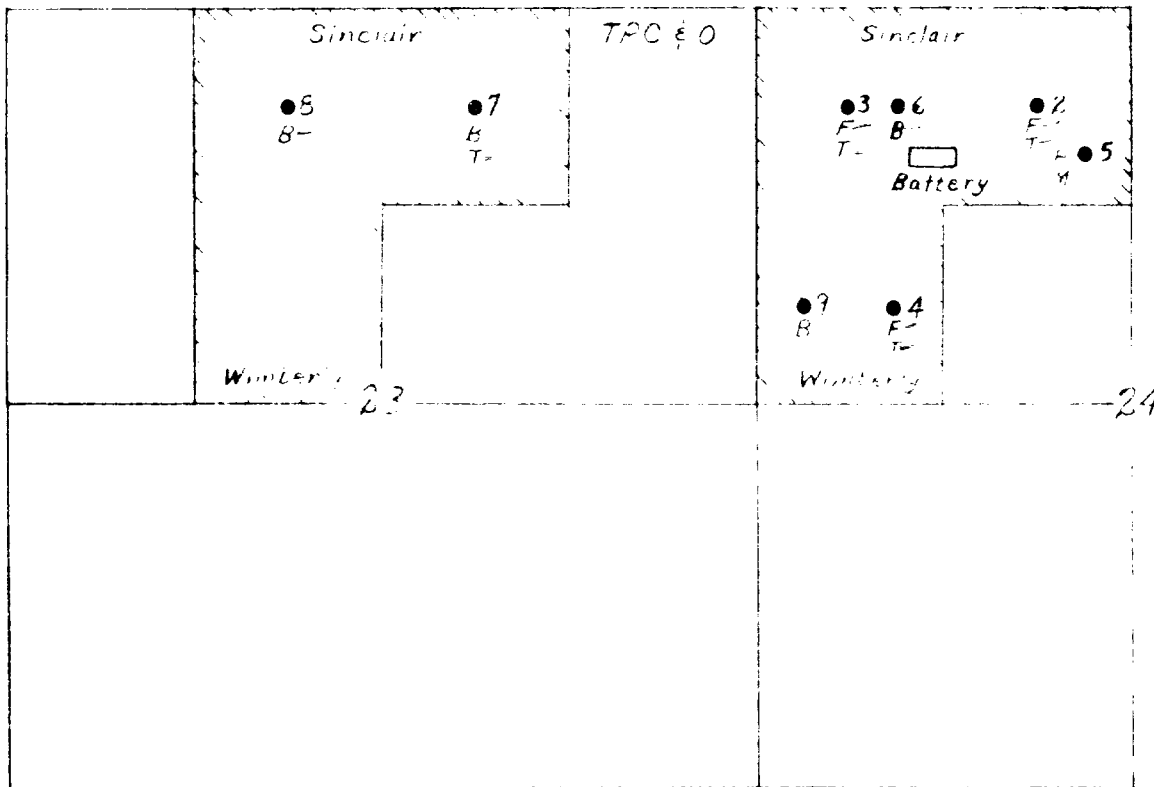

B--Blinebry

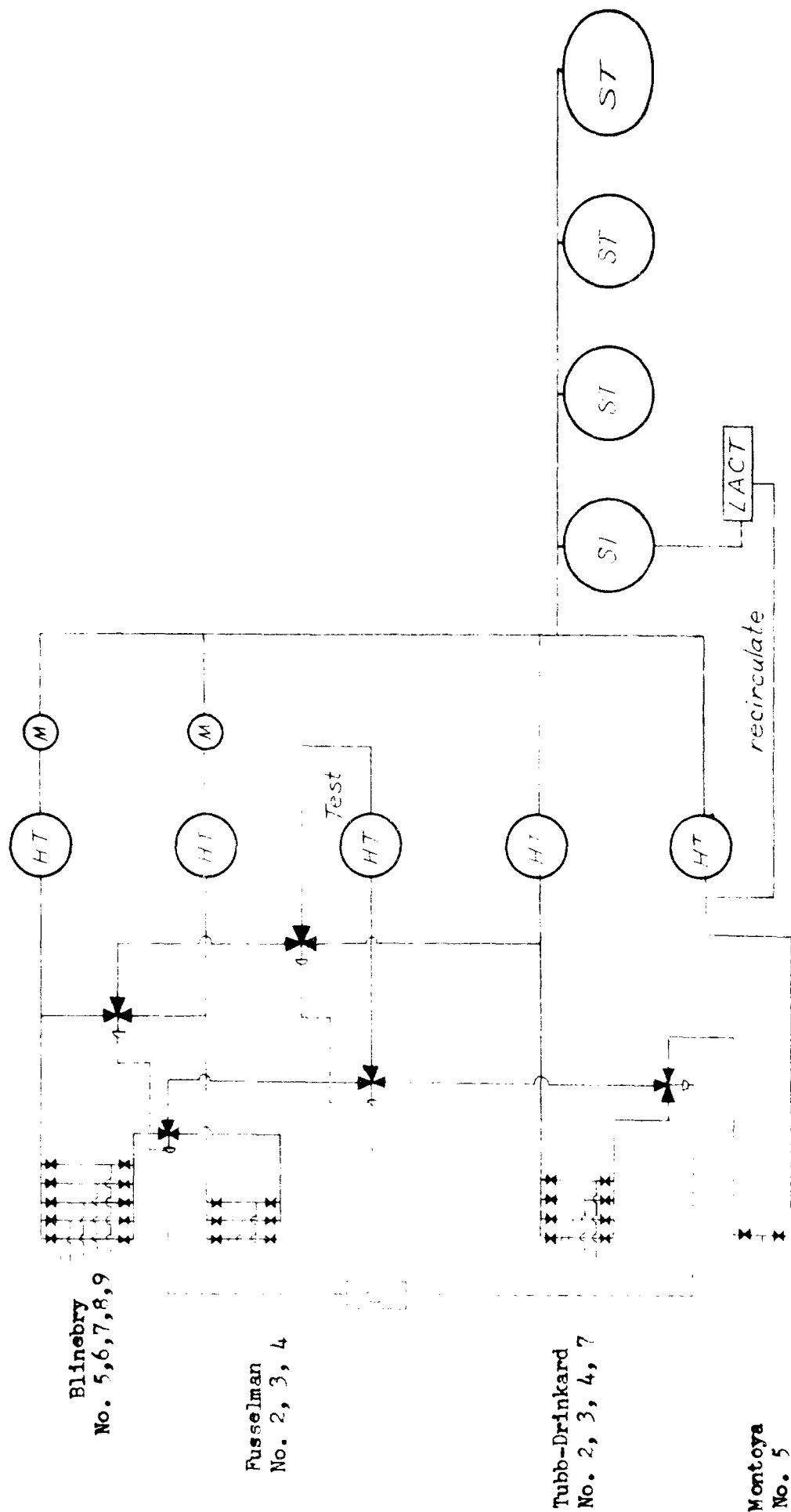
F--Fusselman


