Gentlemen:

Reference is made to your application dated May 17, 1965, for administrative approval of an exception to Rule 303 (a) of the Commission Rules and Regulations to permit the commingling of Drinkard and Blinebry oil production and Blinebry Gas Pool and Tubb Gas Pool distillate production on your F. F. Hardison B<sup>-</sup> Lease comprising the SE/4 of Section 27 and the NE/4 of Section 34, Township 21 South, Range 37 East, Lea County, New Mexico, after separately metering the combined Tubb and Blinebry distillate streams and determining the Blinebry and Drinkard oil production by means of the subtraction method. Allocation to each of the pools would then be on the basis of periodic well tests. It is our understanding that all wells on said lease are of marginal nature.

By the authority vested in me under the provisions of Rule 303 (b) of the Commission Rules and Regulations, you are hereby authorized to commingle the production from the aforesaid pools on said lease in the above-described manner. Provided, however, that the installation shall be operated in accordance with the provisions of the Commission Manual for the Installation and Operation of Commingling Facilities, and provided further, that you shall notify the Commission at such time as any well in any of the aforesaid pools is capable of top allowable production.
