Bass Enterprises Production Company respectfully requests your approval of our applications for Rules 309-B and 309-C regarding lease commingling and off-lease storage on the subject dually completed well. Bass proposes commingling the sweet crudes from the Morrow and Wolfcamp formations on the surface so that they may be transported off-lease to the tank battery using the same flowline. Bass currently operates two wells in the area, the Merchant State No. 1 producing sour crude from the Palmillo (Bone Springs) Field and Palmillo State No. 1 dually producing sweet crude from the Undesignated (Wolfcamp) Field and gas and condensate from the N. Turkey Track (Morrow) Field.

The Bass Merchant State Lease, No. E4397, covers the SW/4, S/2 of SE/4, and N/2 of Sec. 1, T19S, R28E. The Bass Palmillo State Lease, No. B11339, covers the N/2 of SE/4 of Sec. 1, T19S, R28E, both in Eddy County, New Mexico. Being state land, the State of New Mexico is the beneficiary of the royalty.

Production from the Palmillo State No. 1 will be accurately measured using a positive displacement Flowco meter prior to commingling and will be properly segregated from the sour crude at the off-lease storage facility. Attached are diagrams of the commingling and off-lease storage facilities as well as a plat showing the Bass acreage and producing wells. As can be seen, the sweet crude produced off-lease has its own separation and storage facilities and in no way can be mixed with the sour crude.

If the Palmillo State No. 1 were not dually completed, the State of New Mexico would lose revenue. If the Morrow zone were shut in (at a 4,000 MCF/day rate), the State would lose approximately \$1,400/day. If the Wolfcamp zone were shut in (at top allowable 230 bbls/day rate), the State would lose approximately \$1,100/day. Both zones can produce at the rates used in the economics. The economics are based on the State's receiving a 1/8 royalty.




