Gentlemen:

Alpha Twenty-One Production Company requests administrative approval of an exception to Rule 303-A in order to commingle Blinebry and Tubbs production on our Lea Well Nos. 1 and 2. Lea No. 1 well, located Unit Letter B, 660' FNL and 1650' FEL, Sec. 17, Twp. 23-S, Rge. 37-E, Lea County, New Mexico is completed in the Blinebry pool and is a marginal producer at one BOPD. Lea No. 2 well, located Unit Letter A, 850' FNL and 950' FEL, Sec. 17, Twp. 23-S, Rge. 37-E, Lea County, New Mexico is completed in the Tubbs pool and also is a marginal producer at eight BOPD. The Blinebry produces 160 BWPD and 125 MCF and the Tubbs produces 15 BWPD and 40 MCF. Production from the Blinebry and Tubbs will be allocated back based on well tests.
