Amendment Administrative Order PLC-1

Gentlemen:

Reference is made to your letter dated April 10, 1964, wherein you state that the production from each well covered by Administrative Order PLC-1 has declined to a marginal status and that no well is capable of producing top allowable any longer. You therefore request permission to remove the metering equipment which is required by Administrative Order PLC-1.

The Commission's "Manual for the Installation and Operation of Commingling Facilities" provides that separate metering facilities must be provided even for marginal production in the event royalty, overriding royalty, and working interest is not indentical throughout when commingling more than one lease. The Manual further provides that marginal production from more than one pool on any given lease may be commingled without separate metering facilities. Administrative Order PLC-1 provides that the production from each lease and each pool is to be separately metered.

Please advise as to the exact arrangements you would propose to make in revising your present commingling installation.


Dear Sir:

Gentlemen:

Cabot Corporation is presently commingling production in the North Bagley Field, Lea County, New Mexico, under authority granted by Administrative Order PLC-1 dated June 6, 1963. Production from the Wolfcamp and Upper Pennsylvanian zones is being commingled after being separately metered, and the oil is stored in tankage located on our Humble State lease. Gas produced with the oil from each zone is sold after separate measurement.

A decline in the producing ability of each well covered by the above mentioned order has caused all wells to be physically incapable of producing top unit allowable for their respective pools. Therefore, we request permission to remove the metering equipment from these wells and to determine the production from each well by conducting individual well tests at such times as may be prescribed by the Commission. Attached hereto is a tabulation of the average daily production for the past five months.

Reference is made to Administrative Orders PC-102 and CTB-91, entered by the Commission October 5, 1962, and amended December 3 and 18, 1962, March 8, 1963, and May 6, 1963, which permitted commingling of Wolfcamp and Upper Pennsylvanian production from your Humble State Lease, State "L" Lease, J. R. Thompson Lease, and State "M" Lease in the North Bagley Field, Lea County, New Mexico.

In order to clarify the status of this commingling installation and simplify administration thereof, we are hereby superseding all previous orders by this Administrative Order, PLC-1.

This order authorizes the commingling of Wolfcamp production from your Humble State Lease, State "L" Lease, and John R. Thompson Lease and Upper Pennsylvanian production from your State "M" Lease after separately metering the production from each lease and each pool.

You are further authorized to substitute the Upper Pennsylvanian for the Wolfcamp on the State "L" and Thompson Leases after depleting the Wolfcamp horizon, provided however, that this office shall be notified at the time of such substitution.

In order to clarify the operations being conducted at Cabot's central tank battery on our Humble-State lease in the North Bagley Field, the following verbal and schematic description is submitted.

Operation of this battery is authorized by Administrative Orders PC-102 and CTB-91 as amended. Wells and producing zone producing into this central battery are:

Humble-State No. 1	Wolfcamp
State "L" No. 1	Wolfcamp
J. R. Thompson No. 1	Wolfcamp
State "M" No. 1	Upper Penn.

Oil production from each lease is metered separately, as indicated on the schematic drawing, before commingling in common storage. Gas sales from each lease are also metered separately.

Administrative Orders PC-102 and CTB-91 have in the past granted permission to commingle Upper Penn production from the State "L" and John R. Thompson leases into the central battery located on the Humble-State lease. Although the Upper Penn is not currently being produced from these two leases it is hereby requested that Administrative Orders PC-102 and CTB-91 be amended, or if new orders are issued, to permit commingling of the following leases and zones into the central tank battery located on the Humble-State lease:

Zone

Humble-State State "L" State "M" John R. Thompson Wolfcamp Wolfcamp and Upper Penn Upper Penn Wolfcamp and Upper Penn.

Cabot anticipates producing the Upper Penn from the State "L" and Thompson leases after depleting the Wolfcamp horizon. Each zone will be separately metered if and when they are produced.


